Dear Client,

Please read this letter about the HIV Drug Assistance Program (HDAP). Fill out and return the included Insurance Enrollment Report (IER) (F-01423) by December 8, 2025. Information on where to send the completed form is listed below.

We are sending you this letter because HDAP may be paying your insurance with drug coverage. If you do not currently have and are eligible for insurance, you must sign up to keep HDAP as payor of last resort. The types of insurance that the HDAP can pay for are listed on the enclosed IER.

## If you would like HDAP to pay for next year's insurance by January 1, fill out and send the form back by December 8.

Only send the form when you know what next year's premium will be. You may lose your insurance if you do not send us your plan details by December 8, 2025.

## Other notes:

- Open enrollment for Silver Plans from the Marketplace is available from November 1, 2025, to January 15, 2026. You must take full tax credits. You can enroll at www.healthcare.gov. HDAP can pay for individual premiums up to \$400 a month after tax credits are applied. There may be exceptions.
- Open enrollment for Medicare Part D plans is October 15, 2025, to December 7, 2025.
- Beginning January 1, 2026, HDAP is no longer able to cover Medicare Supplement (Medigap) premiums. For help picking a different plan, contact the Medigap Helpline at 800-242-1060.
  - o HDAP can pay for a Part C (Medicare Advantage) Plan if it has drug coverage.
  - If you have Medicare due to a disability determination, Medicaid Purchase Plan (MAPP) may be a coverage option. HDAP can pay MAPP premiums.
- If you think you qualify for BadgerCare, apply at access.wisconsin.gov.
- If you are employed and are offered employer-sponsored health insurance that covers medication, please sign up during your open enrollment period.

To return your complete IER form, you may mail, email, fax, or upload the document to our new HDAP Online Portal (HOP). For the HDAP to receive your form faster, email, fax, and using HOP methods are preferred. View submission information below.
