### Administrative Updates (Katie Sepnieski & Kathy Welke)

- May 1 May 7, 2022 was Economic Support Specialists and Case Manager week.
- Nikia Morton, the Operational Lead from Dane County/Capital Consortium resigned effective May 18, 2022.

### Approval of April 14, 2022, Meeting Minutes (Katie Sepnieski)

Motion to approve the minutes made by Tony Sis and John Rathman and approved by consensus.

### Policy Updates/COVID-19 Policy updates (Autumn Arnold)

### FoodShare Emergency allotments

- The Emergency Allotments (EA) were approved for May 2022.
  - o Benefits will be available for members on May 22, 2022.
  - o The catch-up run will be available for applicable members on July 17, 2022.
- DHS received approval on Tuesday to issue EA for June 2022.
  - o Benefits will be available for members on June 12, 2022.
  - o The catch-up run will be available for applicable members on August 14, 2022.
- There is a change to the scheduled date for the April 2022 EA catch up run. That catch up run is now scheduled
  for the first weekend in June, with benefits available for applicable households on June 5, 2022. That catch up
  run was previously planned for June 12. Information will be shared with partners and a CARES Coordinator
  Notice will be sent about the date change.

### Public Health Emergency (PHE) Unwinding

- The Department of Health Services (DHS) would have received the 60-day notification on May 16<sup>th</sup>, 2022 if the PHE was ending in mid-July. DHS did not receive notification.
- The CMS has confirmed that there will be another 90-day extension of the PHE through mid-October 2022. This is a planning assumption, not a guaranteed timeline.
- DHS does not expect the formal extension of the PHE to happen until close to the current expiration date.
- The next major milestone DHS is tracking is August 16, 2022, as the federal government will give States at least 60 days' notice before the PHE ends.
- If the PHE ends in October 2022, the earliest members could have a change in MA benefits would be the end of November, 2022 Early October, 2022 would be the soonest that DHS would start contacting members about actions required to maintain coverage.
- DHS is in the process of updating timelines and assessing unwinding efforts based on the new PHE end date.

#### C9 Code

DHS discussed at the May 13, 2022 Income Maintenance Operational Analysis Subcommittee meeting (IMOA)
the intent to change the system effective August 1, 2022 to expire the C9 Code which would then prompt
workers to seek verification when processing applications, change reports, or renewals on cases with a C9 code.
The benefit to resolve the C9 code on existing cases prior to a full renewal is due to non-health care programs,

which do not require waiting until the renewal to take a negative action for existing cases and non-health care programs want to verify reported changes according to the program policy.

### **COVID Unwinding System and Policy Changes**

- Mai Yee Xiong presented information on the Address Change Prompts in ACCESS and MyACCESS release for June 2022 as an effort to obtain updated addresses from members prior to PHE unwinding. See attachment for additional details.
- Nick Hayward and Shawn Thomas presented information on the Reasonable Compatibility Threshold release for
  June 2022 in preparation for the PHE unwinding effort. There continues to be active discussions on if the 20%
  threshold will be implemented in June 2022 based on the date change for the PHE end date. See attachment
  for additional details.
- Nicole Huffman and Shawn Thomas presented information on systems changes for COVID unwinding Continuous Coverage for Healthcare. See attachment for additional details.

### Subcommittee Updates (Income Maintenance Agency Subcommittee Co-Chairs)

- IMOA subcommittee met on May 13, 2022. Doreen Lang shared key discussion points from that meeting (see attachment). Next meeting is June 1, 2022.
- IM Training Subcommittee met on April 25, 2022. Anna Dubinsky shared key discussion points (see attachment). Next meeting is July 25, 2022.
- Call Center Operational/Technical subcommittee met on March 28, 2022. Kris Weden shared key discussion points (see attachment). Next meeting is May 31, 2022.

### Income Maintenance (IM) Funding and Contract Updates (Alicia Grulke)

- The ARPA Contracts have been signed by the Consortium.
- The PHE Unwinding ARPA Contract has been drafted. The draft language was shared with ESPAC to provide feedback. DHS intends to release the contracts as close to the 60-day notification as possible once the notification is received that the PHE is ending.
- The negotiations for 2023 Income Maintenance Contract will begin in June or July 2022.

### Consortia Feedback (Kathy Welke)

- Could "processing applications" be specifically included in the language for allowable use of the funds for the PHE Unwinding ARPA contract?
- Would it be possible for funds to be available starting 60 days before the end of the PHE (when official notification of the end is received from the Federal Government) to allow for training time of temporary staff hired to assist with the increased workload?

### Administrative Memos (Alicia Grulke)

- Administrative Memo 17-07 Income Maintenance Training Roles and Responsibilities memo is currently being reviewed and updated and will be sent to consortia for 45-day review.
- *PII Administrative Memo* continues to be reviewed by Office of Legal Counsel.

#### Regional Enrollment Network (John Rathman)

- Regional Enrollment Network (REN) members reviewed PHE unwinding plans and efforts to reach out to current Medicaid members.
- REN membership was encouraged to help revitalize regional RENS that can be valuable groups to assist with PHE unwinding.

• The Fall REN conference has been finalized. Pre-licensing will be September 14- September 16, 2022 from 9am-12pm each day. The main conference will be held from 9am-12pm on September 28-September 30, 2022 and October 3-October 4, 2022.
