FoodShare Updates

- Handbook updates
  - Handbook updates will be published on December 5, 2022. This includes the FoodShare and FSET handbooks.
- Emergency Allotments
  - Emergency Allotments has been approved for November 2022. Benefits will be issued to open FoodShare households November 19, 2022, and available to members November 20, 2022.
  - The November 2022 catch-up run is scheduled for January 7, 2023, with benefits available to members on January 8, 2023. This includes any FoodShare households eligible for benefits for November 2022 that were confirmed eligible for benefits after November 19, 2022.
  - Emergency allotment benefits have been requested for December, currently awaiting approval from Food and Nutrition Services (FNS).

- Regional Enrollment Network (REN) committee met on November 8, 2022.
- Members reported a busier start to open enrollment than in recent years.
- Covering Wisconsin shared promotions that would be launched. A variety of media is being used to share information out regarding open enrollment.
- Updates were shared on progress to re-invigorate the RENS statewide. Strategies being used to engage partners in meetings, include surveying partners about topics of interest at future meetings.
- Office of Commissioners Insurance (OCI) shared the Open Enrollment toolkit they developed and that is now available in E, S & H. They also shared some of the social media posts that have been developed.
