• April renewals are in process and May renewals are beginning. June is the last month post-public health emergency renewals due.

- BadgerCare Plus children's premiums went into effect for new applicants who applied on or after April 1, 2024.
 - For existing members, premiums will go into effect on a rolling basis as families complete their next renewal.
 - May 2024 is the first month premiums are due. Statements are being mailed out for May 2024.
- In June 2024, the Department will communicate premium reinstatement to Medicaid Purchase Plan (MAPP).
 - Premiums will be set in July 2024 and members will receive notices and premium statements for premiums due in August 2024.
