- Improve worker efficiency


# Changes to CWW

# **Data Exchange Query Page**

The following new query fields will be added to the Data Exchange Query page.

- View SSA Benefit Change Summary History (BENDEX, WTPY) – when selected, workers navigate to the new SSA Historical Information Summary page.
- View SSI Benefit Change Summary History (SDX, WTPY, State SSI) – when selected, workers navigate to the new SSI Historical Information Summary page.
- View SSBC Potential Duplicate Benefits in Another State – when selected, workers navigate to the SSA Details page for ONLY SSBC records.



### **Auto-Update Enhancements**

The Unearned Income, Medicare, and Benefits Received pages are auto updated based on the data received in CARES from the SSA via BENDEX/WTPY/SOLQ-I.

- Sometimes the SSA sends Social Security payment information before an individual is entitled to the payment. As a result, BENDEX Begin Date logic will be updated to accurately populate the Begin Month field on the Unearned Income and Benefits Received pages in the future month.
- Currently, SOLQ-I is updating multiple sequences of end dated records. After implementation, if a repeating \$0 amount is received, no sequence will be created or updated for the \$0 record on the Unearned Income and Medicare pages.

### **Alerts and Case Comments Enhancements**

The following alerts will no longer be created. Instead, a case comment will be entered.

- 370 FYI SS INCOME UPDATED
- 371 NEW SS INCOME ADDED
- 381 MEDICARE INFO END DATED
- 382 SS INCOME END DATED

### **New Alerts**

The following new alerts will be created:

- 635 VERIFY INDIVIDUAL INCOME TYPE SSRE OR SSDI will display when the member is receiving SSRE but applied for disability through SSA.
- 636 CONTACT SSA TO VERIFY THE DEFERRED PAYMENT AMOUNT will display when the benefit payment status code is a deferred status type.

**Note:** More information about these (and other changes/fixes) will be communicated in a separate SSA DX CARES Bulletin prior to implementation.

# **SDX Discrepancy Enhancements**

Currently, during the SOLQ-I process, the following discrepancy is created in situations where a Federal SSI payment exists without a State SSI payment:

> Federal SSI – Add State SSI (SISS)

After implementation, this discrepancy will be created with the BENDEX batch process.
