- As IAC members were notified through email, Christian Moran will no longer be a part of the IAC meetings as he has left to take on a new position.
- Thank you for feedback regarding disenrollment notices.
- A request for procurement (RFP) is open for Fiscal Employer Agencies (FEAs).
 - O DHS cannot discuss details as it is an open procurement.
 - o A member requests that the FEA be based in Wisconsin.
 - o Applications are due in September 2025 for implementation in 2026-27.
 - o A member asks that participants be included in discussions.
- Competitive integrated employment (CIE) information and reports are now available online (dhs.wisconsin.gov/employment-skills/index.htm).
- Provider management overall enrollment tracker is now available (<u>forwardhealth.wi.gov/WIPortal/cms/public/ltc/provider_enrollment.htm</u>), and there are updated materials in the handbook. As of July 14, 2025, more than 2,000 home and community-based services (HCBS) are enrolled.

Background Check Policy - Appeals Process Update

Jennifer Ruid - Program and Policy Analyst, DHS Bureau of Programs and Policy

Reviewed materials that were sent ahead of the meeting.

Feedback

• If there is an item on a background check that the applicant has forgotten, the DHS is still required to follow the background check policy. However, the findings that are prohibitive are ones that an applicant is unlikely to have forgotten.

- Will this be designed in such a way that information can be submitted or received through email? It is still under consideration.
- FEAs are the contact point for participant questions
- How many appeals will be reviewed each month? DHS: We will have a better idea after we begin.
- There should be some written confirmation for people to acknowledge that they received the information. DHS: This would add additional time and delay in the hiring process, but applicants and participants will be given the relevant information.
- What happens if an established and active participant-hired worker fails a background check? The FEA notifies the IRIS Consultant Agency (ICA), and the IRIS Consultant (IC) contacts the participant and the worker to inform them that the worker is no longer eligible for Medicaid reimbursement. The IC also ensures that there are other established care staff so the participant's needs will be met.

IRIS Waiver Changes

• Covered material that was shared ahead of the meeting.

Feedback

- Concern raised about training new personal care workers for higher-needs participants. DHS: This will be addressed within policy or other IRIS resources.
- Are camps a respite resource? Yes, they have always been available in IRIS and are still available.
- Family Care self-directed support is different because the ICs already provide the service.
- A one-pager for participants would be beneficial. DHS: There will be information disseminated, including new codes, before rollout, and a one-pager could be included.
- How do IRIS participants fit into the plan for dual-enrollment requirements? This is something that will be evaluated further but is not directly impacting the waiver.
- Provider-managed is different than participant-hired per CMS rules. This is co-employment. Participants who choose to utilize an agency agree to employ the workers managed by the agency.
- How will training code under EVV? One member reports that they use one personal care and one home care while another member states they have not been permitted to have two providers at one time. DHS: This will be clarified in future materials.

 - Support broker services should be protected.
 - o There should be a service code addressing community integration.

 - o Having a support broker might assist in getting needs met.
 - o There is technical error risk using electronic visit verification (EVV).

 - Caller is concerned that fewer FEAs means that participants are not being given choice.

Acumen Transition

Sheldon R. Kroning - Section Manager, DHS Bureau of Quality and Oversight

- Acumen notified the DHS that they will be ending their contract as an FEA.
- Last week, a letter communicating this change was sent to participants.
- Around 1,800 people will be transitioning out of Acumen.
- Premier will not be part of the transition process, so Premier will not take in Acumen transfers. They will remain an option for standard transfers and new participants.
- iLIFE cannot take participants who utilize First Person Care Consultants due to a conflict of interest, so those participants will be automatically changed to GT Independence. This means a small subset of people currently

- enrolled with Acumen will not have a choice in FEA. After the transition, the participant can transfer to iLIFE if they change their ICA.
- Participants enrolled in Acumen who do not utilize First Person Care Consultants have until August 15 to choose their new FEA.

Feedback

• What will happen to the staff who work for Acumen? Acumen remains a fiscal agent but not contracted with IRIS, so no staff will lose their employment.
