Phase II - UW Eau Claire Music & Memory Project: Impact on Facilities and Staff

Pre- and Post-test (3-month), and follow-up (6month) survey design:

- Study of staff job satisfaction, facility working environment, staff retention;
- Staff expectations (pre-test); and (Sent 1/6/2015)
- Staff responses and observations (post-test and follow-up)
- Facility Director or Unit Manager follow-up
