\*\*\* Lus Cim: Cov neeg uas nyob hauv ib lub tsev laus los yog ib qhov chaw Community Based Residential Facility (CBRF) yuav sau npe tsis tau rau hauv IRIS.

Lus Cim: Cov neeg uas luag tshuaj ntsuam pom tias muaj tus Kab **Mob Raum Rau Theem Kawg Lawm** yuav tsis muaj cai sau npe tau txais kev pab hauv Partnership, tshwj tias cov neeg no muaj npe tau txais kev pab hauv ib lub Managed Care Organization (MCO) uas muaj tsoom fww teb chaws ib qhov kev zam tau tso cai rau txoj cai tswj no xwb. Tsuas yog ib lub MCO, Community Care Inc., nkaus xwb thiaj muaj tsoom fww teb chaws ib qhov kev zam tau tso cai los mus sau npe kom tau txais kev pab rau cov neeg uas muaj tus Kab Mob Raum Rau Theem Kawg Lawm lub sijhawm no. Cov neeg uas muaj tus Kab Mob Raum Rau Theem Kawg Lawm tej zaum yuav sau npe tau rau hauv PACE.

Lus Cim: Cov cai hais txog qhov **Mus Muab Tej Cuab Yeej Cuab Tam Los Them Nqi (Estate Recovery)** muaj siv rau Family Care, Partnership, IRIS, thiab yuav siv rau PACE thaum lub 7 Hlis tim 1, 2014. Ib qhov ntxiv, cov neeg uas xaiv PACE tsis tau them cov nyiaj yus nrog them (co-pays) los yog cov yus them ua ntej (deductibles) rau cov tshuaj uas kws kho mob ua ntawm mus yuav.

Lus Cim: Yuav kom muaj cai tau txais kev pab rau Partnership, koj yuav tsum muaj npe tau txais kev pab hauv txhua seem ntawm Medicare uas koj muaj cai tau txais.
