The following chart is a **partial** listing of long-term care and health related services. The chart indicates whether the service is included in the specific program's benefit package. The services that a person actually receives are based on assessed needs and other program specific requirements. Some services may require prior authorization.

**With the help of an interdisciplinary team, participants in Partnership choose their long-term care providers and their health care providers from the network offered by the Managed Care Organization (MCO).

People who have a diagnosis of **End Stage Renal Disease** are ineligible to enroll in Partnership unless they are not eligible for Medicare.

Estate Recovery provisions apply for Partnership and for ForwardHealth Card services.

To be eligible for Partnership, you must be enrolled in every part of Medicare for which you are eligible.
