

## OARS program completion

OARS program participants may be enrolled for up to two years after release from the institution. Successful program completion criteria include:

- Participant is maintaining stable housing independently.
- Participant is living without reliance on alcohol or illegal drugs.
- Participant is actively engaged in his/her treatment and has transitioned to locally based services in his/her county of residence.
- Participant is financially able to maintain their treatment, housing, and basic needs without assistance from OARS.
- Participant is making healthy decisions regarding recovery and mental health stability.

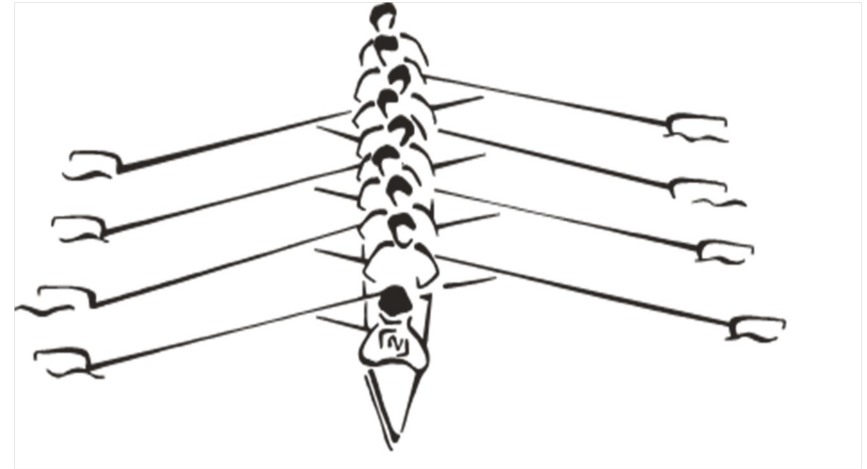

- Promote offender self-sufficiency
- Decrease long term costs associated with this population

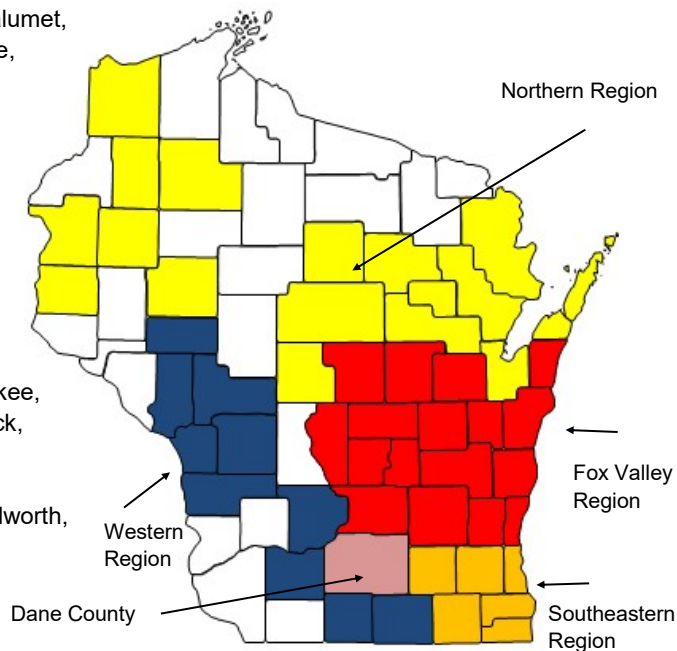
## Who the program serves

OARS serves a limited number of offenders releasing from the Wisconsin Resource Center, Wisconsin Women's Resource Center, and Department of Corrections adult institutions to a county served by the program who:

- Have a minimum of six months of supervision upon release.
- Have serious and persistent mental health needs.
- Rate moderate to high risk of reoffending according to the Department of Corrections assessment.
- Demonstrate a general motivation and willingness to engage in treatment programming.
- Agree to participate in the OARS program.

## Program team members

A team works together to develop a comprehensive Individualized Service Plan before and after release from prison to help the participant successfully reintegrate into the community. OARS team members include:

- OARS participant (Offender)
- Institution social worker
- Community corrections agent
- OARS case manager
- DHS program specialist
- Natural supports
- Treatment providers in the community

## Services provided

- Assistance with obtaining and maintaining safe and affordable housing
- Resources for medication and access to quality psychiatric care
- Access to healthy and meaningful structured activities, including educational programs, volunteer opportunities, and employment
- Treatment options to address individualized needs
- Social support and acceptance
- Access to local transportation, budgeting, and financial resources

## Participant responsibilities

- Follow all rules of supervision
- Work with OARS team to identify treatment and educational opportunities available before and after release from the institution
- Cooperate with treatment, including taking all medications as prescribed, before and after release from the institution
- Participate in the development and review of the Individualized Service Plan
- Meet with the assigned OARS case manager and community corrections agent
- Sign releases of information and consents for housing and treatment services
- Be responsible and respectful with regards to any housing that is provided
- Communicate with an OARS team member regarding any concerns about the program expectations
