#### **Complaints and Fair Hearings**

Thov Cim Cia: Cov lus nram qab no yog hais txog kev thauj neeg mob uas tsis yog mob ceev. Yog tias koj muaj ib tug mob ceev koj yuav tau hu rau 911.

Kev thauj neeg mob uas tsis yog mob ceev yog caij cov tsheb thauj tsoom neeg sawv daws (public transportation) thiab caij nrog lwm tus (shared ride service). Cov tsheb thauj kuj muaj xws li cov tsheb thauj tsoom neeg sawv daws (ib yam li cov tsheb npav (bus) kхиav hauv nroog), cov tsheb tshwj xeeb thauj neeg mob, los yog lwm hom tsheb nyob ntawm koj tus mob thiab kev mus los cov kev xav tau. Yog tias tsis muaj hom tsheb thauj tsoom neeg sawv daws, koj tsis tas yuav tsum tau caij xwb li.
