g. Cases are presented by current gender rather than sex at birth. During 2014-2018, a total of 25 transgender persons were newly diagnosed with HIV in Wisconsin.

h. Race/ethnicity breakdowns are not shown if the cell in the subgroup has either a value of <5 or an estimated population size (denominator) <100. In such cases, the multi-racial or unknown

category along with any cells that equal zero are suppressed to prevent interpolation of the suppressed cell(s). Rates for multi-racial persons are not shown because population denominators for this group are not available in the demographic data source.

i. Age when first diagnosed with HIV infection, except for prevalence cases, where it is the current age.
