#### **Births to Hispanic Women in Wisconsin (Reference Tables)**

This set of tables presents maternal and child health-related data about Hispanics in Wisconsin. These data are for the use of program managers in the Division of Public Health and local health departments that serve Hispanic populations. Preparation of these tables was supported by the Division of Public Health, Bureau of Family and Community Health, and by the Division of Health Care Financing.

These tables present information on population, birth characteristics, fertility (including births to teens), and infant mortality. Data are presented separately for the two major Hispanic subgroups in the state: those who report origins (birthplace or ancestry) in Mexico or Puerto Rico. Data are based primarily on birth certificate data for the years 1990-1999, and also include U.S. Census data for Wisconsin from 1990 and 2000.

The principal national origins of Hispanics in Wisconsin are Mexican (66 percent of the Hispanic population in 2000) and Puerto Rican (16 percent). Maternal and child health statistics have not previously been presented for these two groups in Wisconsin.




## Births to Hispanic Women, Wisconsin 1999

#### **Data Sources and Technical Notes**

#### **Births**

Data on live births in this set of tables are drawn from birth certificate files, which are part of the state vital records system maintained by the Vital Records Section of the Bureau of Health Information.

Data extracts from annual birth files for the years 1990-1999 were combined for this analysis. The birth files were in the same format throughout the period.

Race and Hispanic ethnicity data are collected in separate items on the birth certificate from both the mother and the husband (if the mother is married). In this set of tables, births are classified according to the race/ethnicity of the mother. The Bureau of Health Information (BHI) constructs a combined race/ethnicity variable for its reporting. In BHI reporting on Wisconsin births in its annual publications, *Wisconsin Births and Infant Deaths* (1995-present) and *Maternal and Child Health Statistics* (1982-1994), race and ethnicity are reported in a single variable with six mutually exclusive categories: non-Hispanic white, non-Hispanic black, non-Hispanic American Indian, non-Hispanic Southeast Asian (to 1993) or Laotian/Hmong (1994-present), Hispanic, and all other. In this set of tables, the American Indian, Southeast Asian or Laotian/Hmong, and all other categories are combined to form the "other" race category.

Very few Hispanics in Wisconsin belong to racial minority groups. In 1990-1999, only 3 percent of births to Hispanic women were to mothers whose race was other than white. In 1990-1999, the annual average number of births to Hispanics by race of mother was:

The question on Hispanic ethnicity on the birth certificate is a query on the specific origin of the mother as well as a question on whether the mother is Hispanic. For example, here is the question in the worksheet for hospitals that report birth data electronically: "Is mother of Hispanic origin? Check 'NO' or specify Cuban, Mexican, etc." Instructions to hospital and medical staff who collect information for the birth certificate are as follows:

For purposes of this item, "Hispanic" refers to those people whose origins are from Spain, Mexico, or the Spanish-speaking countries of Central or South America. Origin can be viewed as the ancestry, nationality, lineage, or country in which the person or his or her ancestors were born before their arrival in the United States. There is no set rule as to how many generations are to be taken into account in determining Hispanic origin...The response should reflect what the person considers herself or himself to be and is not based on percentages of

ancestry (Wisconsin Department of Health and Family Services, Vital Records Section, "Hospital Handbook for Vital Statistics," page I-24).

The "other Hispanics" category in this set of tables includes Cubans, Central Americans, South Americans, and Hispanics of unknown or unstated origin (i.e., only "Hispanic" or "Latino" reported).

Births were classified as premature (less than full term) if the gestational age was less than 37 weeks. To determine gestational age, a prematurity index is used; this is usually based on the computed estimate of gestational age, which is the difference between the date of last normal menses and the date of the infant's birth. The clinical estimate of gestational age (reported by the physician directly on the birth certificate) is substituted when the date of last normal menses is unknown.

#### **Infant Deaths**

The matched infant death file is the source for infant mortality data. The matched file consists of data on the death certificates matched to corresponding birth certificates. An infant death is a death occurring to a liveborn child less than one year of age who resided in the state at the time of death.

Denominator data for infant death rates, which relate infant deaths to the number of live births, come from the birth certificate files. For both the infant death and live birth data used to compute infant mortality rates, ethnicity and race are measured by race/ethnicity of the mother, as reported on the birth certificate.

Infant death rates are not reported for fewer than 20 deaths because such rates are subject to large fluctuations.

#### **Population Counts and Birth Rates**

The 1990 US Census provided population data for the birth rates presented in this report (see Tables 8 and 9). The source of the data was the publication, "1990 Census of Population, General Population Characteristics, Wisconsin, CP-1-151," instead of the Census Modified 100% Edited Detail File ("MARS" file), the source of most BHI population data from the 1990 census. The hard-copy report was used for these tables because the MARS adjustments did not apply to the specific Hispanic-origin groups.

Birth rates are not reported for fewer than 20 births because such rates would be subject to large fluctuations.

This set of tables does not include fertility rates for 1991-1999. Population estimates are available for computing fertility rates for Hispanics for the intercensal years (1991-1999), but those estimates substantially underestimate the number of Hispanics in Wisconsin; the 1999 estimate of the Hispanic population was 140,235, while the 2000 census count was 192,921. Calculating 1991-1999 birth rates for Hispanics based on intercensal estimates would overstate Hispanic birth rates, especially for the later years of the decade.
