

Tus Nqi Tus Neeg Mob Yuav Tau Them: Cov Lus Nug Uas Nquag Nug

(Cost Share: Frequently Asked Questions)



Daim ntawv no teb txog cov nqe lus nug uas keev pom hais txog tus nqi tus neeg mob yuav tau them. Tej zaum yuav coj cov ntaub ntawv qhia paub no mus siv tau rau koj yog tias koj tso npe rau hauv Medicaid lub khoos kas kev saib xyuas kho mob ncua sij hawm ntev, xws li:

- Family Care.
- Partnership.
- IRIS (Include (Suav Sawv Daws), Respect (Sib Hwm), I Self-Direct (Kuv Taw Qhia Tus Kheej)).
- PACE (Program of All-Inclusive Care for the Elderly (Lub Khoos Kas txog Kev Saib Xyuas Kho Mob Rau Neeg Laus Uas Tsis Cais Leej Twg Li)).

Tus nqi tus neeg mob yuav tau them yog dab tsi?

Tus nqi tus neeg mob yuav tau them yog qhov nqi them txhua hli uas qee cov tswv cuab thiab cov neeg koom nrog yuav tsum tau them kom thiaj li tseem muaj cai tau txais kev pab rau lawv li Medicaid lub khoos kas kev saib xyuas kho mob ncua sij hawm ntev.

Lawv ho yuav xam txog kuv tus nqi tus neeg mob yuav tau them li cas?

Koj income maintenance agency (lub chaw hauj lwm tswj xyuas nyiaj khwv tau los) yuav txiav txim siab txog tus nqi ntawm koj tus nqi tus neeg mob yuav tau them ua ntej koj tso npe rau hauv lub khoos kas kev saib xyuas kho mob ncua sij hawm ntev. Qhov ntaw npaum li cas uas koj yuav tau them yuav saib raws li ntaw cov txuam thawj tseeb. Cov quav piv txwv uas muab teev tseg hauv qab no tsis yog tag nrho ntawm cov txuam thawj tseeb uas yuav siv tau.

- Koj li nyiaj khwv tau los ua ntej them se—Nyiaj ntaw npaum li cas uas koj tau txais ua ntej them nqi se los sis lwm yam kev lov tawm?
- Kev muaj txij nkawm los tsis tau muaj—Koj puas muaj txij nkawm uas muaj nyiaj khwv tau los thiab?
- Qhov chaw koj nyob—Koj cov nqi tsev nyob raug pes tsawg?

Thaum twg kuv thiaj li yuav them kuv tus nqi tus neeg mob yuav tau them?

Yog tias koj muaj tus nqi tus neeg mob yuav tau them, koj yuav tsum them txhua hli. Kev them tus nqi tus neeg mob yuav tau them yuav txog sij hawm them rau lub hli uas koj tso npe rau hauv Family Care, Partnership, IRIS, los sis PACE. Yeej yuav txog sij hawm them txawm tias koj tsuas nyuam qhuav tau txais cov kev pab cuam rau feem ntawm koj thawj lub hli xwb los xij. Tsis hais txog hnub koj tso npe nkag li yeej yuav muaj txoj cai no.

Leeg twg yuav tau txais qhov kev them tus nqi tus neeg mob yuav tau them?

Nrog Family Care, Partnership, thiab PACE, koj xa koj cov kev them tus nqi tus neeg mob yuav tau them mus rau koj lub Managed Care Organization (Koom Haum Kev Saib Xyuas Kho Mob Tau Muaj Kev Tswj Hwm). Nrog IRIS, koj xa koj cov kev them tus nqi tus neeg mob yuav tau them mus rau koj lub IRIS fiscal employer agent (tus neeg sawv cev rau tus tswv hauj lwm fab nyiaj txiag).



Yuav muaj dab tsi tshwm sim rau kuv tus nqi tus neeg mob yuav tau them yog tias kuv xaiv lub khoos kas kev saib xyuas kho mob ncua sij hawm ntev tshiab lawm?

Koj yuav hloov pauv tau koj cov khoos kas, koj lub managed care organization (koom haum kev saib xyuas kho mob tau muaj kev tswj hwm), IRIS fiscal employer agent (tus neeg sawv cev rau tus tswv hauj lwm fab nyiaj txiag), los sis IRIS consultant agency (lub chaw hauj lwm pab tswv yim). Yog xav hloov pauv, mus tham nrog koj lub ADRC (aging and disability resource center (lub chaw muab peev txheej kev pab rau neeg laus thiab neeg xiam oob qhab)) los sis Tribal ADRS (aging and disability resource specialist (tus kws kho mob tshwj xeeb muab peev txheej kev pab rau neeg laus thiab neeg xiam oob qhab)). Lawv yuav qhia rau koj paub txog yam yuav tau ua.

Yog tias koj hloov pauv hauv nrab hli, thiab koj twb tau them koj tus nqi tus neeg mob yuav tau them rau lub hli ntawd lawm, koj tsis tas them nws ntxiv lawm. Tsuas yuav sau cov kev them tus nqi tus neeg mob yuav tau them ib zaug hauv ib lub hlis xwb.
