Implementation Planning	Implementation planning was a separate planning step, using public health logic models and templates to standardize planning and enable the partners to put the plan to use.	Implementation has been viewed as a continuous and integrated process from the beginning. The proposed model relies on shared leadership and accountability for each focus area across the public health system partners.
