Every county in Wisconsin has an agency that will investigate reported incidents of abuse, neglect, self-neglect, and financial exploitation. If you need to talk to someone about suspected abuse of an elder adult at risk (age 60+), call the Elder Abuse Hotline at 833-586-0107 or your local elder-adult-at-risk (EAAR) agency. To report suspected abuse of an adult at risk (ages 18–59), contact your county adult-at-risk (AAR) agency. Some Wisconsin tribes also have an elder abuse agency, an agency that investigates suspected abuse of younger adults with disabilities, or both.
