



**Children’s Long-Term Support (CLTS) Waiver Program
Approved 2018 CLTS Treatment Foster Care Administrative Rates**

The Department of Health Services (DHS) collaborates with the Department of Children and Families (DCF) each year to issue updated CLTS Waiver Program allowable treatment foster care administrative rates. This information is used by county waiver agencies (CWAs) to calculate the CLTS allowable portion of the administrative cost for treatment foster care agencies. Medicaid Home and Community Based Services (HCBS) Waiver funds may be used to provide services to participants residing in allowable substitute care settings; however, federal law prohibits using Medicaid Waiver funds for room and board costs. CWAs must clearly document the costs authorized for CLTS Waiver participants residing in treatment foster care agencies; do not include room or board expenses. The calculation methodology uses the DCF-approved administrative foster care rates, determines the appropriate percentage of the allowable CLTS Waiver costs, and reflects the portion of allowable and nonallowable CLTS costs by the treatment foster care agency. The CWA must document the CLTS Waiver allowable and nonallowable costs on each foster care CLTS Waiver participant’s individual service plan (ISP), to ensure the authorized funding has not been used to supplant child welfare foster care administrative room and board funding.
