



SHIP Health Information Technology Shared Services Gap Analysis

The State Health Innovation Plan (SHIP) Health Information Technology Team identified statewide shared services that will enable health care transformation: 1) a statewide master patient index; and 2) a statewide provider directory. The SHIP project team conducted a survey of organizations in Wisconsin to identify the current state of the implementation of these three shared services.
