

School Immunization Rates by County, Wisconsin, 2024-2025 School Year

Every fall, in accordance with the Wisconsin Student Immunization Law, schools report the aggregate student compliance with the Wisconsin Student Immunization Law to the public health department.

Students are in compliance with the law if they meet the minimum immunization requirements, are in the process of meeting the requirements, or have a signed waiver.

The 'By County' tab contains the results reported from each school for the 2024-2025 school year.

Below are descriptions of the data included on the 'By County' tab.

**For students in grades K-12, the minimum immunization requirements for attending a Wisconsin school include: 4 doses of DTaP vaccine, 4 doses of polio vaccine, 3 doses of hepatitis B vaccine, 2 doses of MMR vaccine, 2 doses of varicella vaccine; (for grades 7-12) 1 dose of Tdap, as well as one dose of a MenACWY-containing vaccine in grade 7 with a booster dose required in grade 12.

Notes:

Parents provide student immunization records to schools. Schools aggregate this information and report the information to public health during the fall of each school year. The Wisconsin Department of Health Services does not have the ability to verify the accuracy of the information that was submitted by schools.

The data in this document display school immunization and waiver rates and should not be used to determine the percent of students who were in compliance with the law. To view the percent of students in compliance with the law, schools should view the links below for public school district compliance and private school compliance.

This year, a meningococcal (MenACWY-containing) vaccine was added to the requirements for students entering seventh grade, and a booster dose was required for eligible students entering 12th grade.

All percentage points have been rounded to the nearest integer.
