

CROSSWALK – OLD AND NEW FEDERAL NURSING HOME REGULATIONS

Department of Health Services / Division of Quality Assurance P-01943 (08/2017)

Effective November 28, 2017, The Centers for Medicare and Medicaid Services (CMS) will re-organize and re-number the federal nursing home requirements found in Appendix PP. This publication matches the federal nursing home tags from Appendix PP in the November 2016 Mega Rule with the new tag numbers effective 11/28/17.
