Txoj cai Individuals with Disabilities Education Act (IDEA) ntu 637(a)(9)(A)(ii) txwv kom cov xeev yuav tsum muaj cov kev cai thiab cov txheej txheem kev txav cov me nyuam tau Part C cov kev pab cuam tshuam thaum ntxov mus rau Part B cov kev pab qhia ntawv ntxov los yog lwm cov kev pab tsim nyog. Cov kev cai thiab cov txheej txheem puav leej yuav tsum qhia Part C lub koom haum coj yuav faj seeb li cas rau xeev lub koom haum qhia ntaub ntawv (SEA) thiab koom haum qhia ntaub ntawv hauv cheeb tsam (LEA) uas tus me nyuam nyob rau thaum tus me nyuam yuav ze muaj hnub nyoog tsim nyog tau cov kev pab qhia ntawv ntxov raws Part B, raws li ntsuas pom los ntawm lub xeev txoj cai.

Wisconsin Birth to 3 Program xyuas kom txhua tus me nyuam hauv Birth to 3 Program muaj LEA ntawv faj seeb xa rau SEA thiab LEA uas tus me nyuam nyob rau thaum tus me nyuam yuav ze muaj qib hnub nyoog tsim nyog tau Part B cov kev pab uas lub State of Wisconsin ces yog cov muaj peb xyoos. Yuav xa LEA ntawv faj seeb mus rau SEA thiab LEA kom muaj tus me nyuam lub npe, hnub yug, thiab niam txiv npe thiab kev sib cuag tau nrog lawv, tshwj tsis yog cov niam txiv "opt out (txiav txim tsis koom)." Yuav muab cov ncauj lus no xa mus rau SEA thiab LEA tshwj tsis yog leej niam leej txiv sau rau hauv tsab ntawv "Opting Out of LEA Notification (Txiav Txim Tsits Koom LEA Ntawv Faj Seeb)" tias lawv "opt out (txiav txim tsis koom)" nrog LEA txoj kev txais tau cov ncauj lus txheeb qhia. Yog tias cheeb koog Birth to 3 Program tsis tau txais tsab ntawv "Opting Out of LEA Notification (Txiav Txim Tsits Koom LEA Ntawv Faj Seeb)" kos npe los ntawm niam txiv thaum tus me nyuam muaj hnub nyoog 27 hli, yuav muab LEA ntawv faj seeb xa mus rau SEA thiab LEA thaum tus me nyuam muaj 27 hli. Yog tus me nyuam raug xa mus rau Birth to 3 Program tom qab nws muaj hnub nyoog 27 hli, yuav thov kom tsev neeg muab tsab ntawv "Opting Out of LEA Notification (Txiav Txim Tsits Koom LEA Ntawv Faj Seeb)" kos npe xa rov qab ua ntej 10 hnub txij li txais tau tsab ntawv "Opting Out of LEA Notification (Txiav Txim Tsits Koom LEA Ntawv Faj Seeb)". Yog ntsuas txoj kev tsim nyog tau kev pab thawj zaug rau tus me nyuam thaum lub caij nws muaj xws li cuaj lub hlis ua ntej nws lub hnub yug, lub cheeb koog chaw khiaj ntaub ntawv yuav faj seeb qhia rau SEA thiab LEA sai li sai tau tom qab ntsuas tiav tus me nyuam txoj kev tsim nyog tau Part C, tshwj tsis yog lub tsev neeg kos npe rau tsab "Opting Out of LEA Notification (Txiav Txim Tsits Koom LEA Ntawv Faj Seeb)" thiab muab xa rov qab ua ntej 10 hnub li hais no.

- Cov kev pab uas tus me nyuam tau txais los ntawm Birth to 3 Program
- Qhov chaw uas Birth to 3 Program muaj cov kev pab ntawd
- Cov ntaub ntawv txog tus me nyuam kawm tag
- Birth to 3 Program cov kev txhawj xeeb txog kev loj hlob uas muaj feem xyuam rau tus me nyuam
- Lub tswv yim pab txhawb ib tsev neeg
- Cov ntawv ceeb toom qhia kev kawm zoo li cas/tswv yim tu xyuas
- Cov ntawv ceeb toom txog cov kev ntsuas los ntawm cov kws qhia hais lus, cov kws qhia siv tes taws, cov kws qhia qoj ib ce, cov xib fwb qhia ntawv tshwj xeeb, thiab lwm cov raws li qhia
