Cov chaw muab CRT yog cov kws tshaj lij uas yuav pab muab cov khoom cuab yeej siv rau kab mob kev nkeeg haum zoo tshaj plaws rau koj thiab koj lub neej.

Koj yuav tau mus muab qhov khoom CRT los sis kev kho khoom CRT ntawm lub chaw txawv yav dhau los.

Koj puas muaj khoom CRT?

Yog tias koj muaj qhov khoom CRT, tham nrog koj tus kws kho mob los sis lub chaw muab tam sim no.

Yog tias koj muaj qhov khoom CRT, nug koj lub chaw muab khoom tam sim no seb lawv puas yog ib lub chaw rau muaj npe hauv Medicaid muab CRT. Yog tias koj lub chaw muab khoom **tsis** yog ib lub chaw rau muaj npe hauv Medicaid muab CRT, koj yuav tau nrhiav qhov chaw muab uas yog.
