ImageTrend Patient Registry contains pre-made reports that are available for any user with Report Writer access to use as needed. This document provides a non-exhaustive list of the most-used reports available in the registry. Reports are frequently added to Patient Registry and will be added as such to this document periodically. If a user would like to amend a report for their specific needs, use the "save as" function to create a separate report.
