Nyob Zoo Cov Niam Txiv thiab Cov Saib Xyuas Me Nyuam:

Peb lub chaw saib xyuas xav ceeb toom qhia rau koj paub txog peb cov kev siv zog los txo cov qib pa radon nyob rau hauv peb lub chaw. **Radon** yog ib cov pa tshuaj khes mis uas tsis muaj ntxhiab tsw, tsis muaj xim, los sis tsis muaj tsos qab. Nws muaj los ntawm cov thaj uranium hauv hav zoov hav tsuag uas yaj los rau hauv av. Radon yog qhov tsim ua rau muaj mob khees xaws rau lub ntsws ntawm cov neeg uas tsis haus luam yeeb. Feem ntau lawm mob khees xaws rau lub ntsws yuav tshwm sim tom qab, yog li ntawd, tiv thaiv cov qib pa radon siab ntawm qhov chaw uas cov neeg nyob, ua hauj lwm, thiab mus kawm ntawv thiab lub chaw saib xyuas me nyuam yog qhov tseem ceeb.
