Rau Cov Chaw Zov Me Nyuam

Radon yog cov roj txaus ntshai uas koj tsis tuaj yeem pom, hnov tsw, lossis saj. Nws los ntawd kev tawg ntawd cov uranium hauv av. Radon yog qhov teeb meem tshwj xeeb vim nws tuaj yeem ua rau mob qog noj ntshav hauv lub ntsws tau, rau cov neeg uas tsis haus luam yeeb. Qhov xwm zoo ces yog Radon tuaj yeem tiv thaiv tau los ntawd kev txo cov qib radon hauv cov tsev uas tib neeg siv sijhawm ntau, xws li tsev nyob, chaw ua haujlwm, tsev kawm ntawv, thiab chaw zov menyuam. Hauv Wisconsin, tag nrho tsev neeg thiab cov pab pawg zov me nyuam uas tau ntawv tso cai yuav tsum kuaj radon kom paub tseeb tias nws muaj kev nyab xeeb lossis tsis muaj kev phom sij. Txoj kev soj ntsuam yuav sib txawv nyob ntawd seb yog tsev neeg lossis cov pab pawg saib xyuas. Daim ntawv taw qhia no nrog rau cov lus nug uas nug heev tshaj (FAQs) yuav piav qhia txog yam koj xav paub txog kev kuaj radon hauv koj cov chaw zov me nyuam.

FAQ

Leej twg yog tus yuav tsum kuaj kuv qhov chaw txog radon?

Koj tuaj yeem kuaj koj lub chaw ntawd koj tus kheej siv short-term radon test-kit. Koj tuaj yeem yuav test-kit tau los ntawm cov khw muag khoom kho vajtse, lossis koj lub chaw Radon Information Center. Txawm tias tsis yuav tus neeg no los tau tab si, [koj tuaj yeem ntiav](#) tus neeg ua haujlwm soj ntsuam txog [radon uas muaj](#) daim ntawv pov thawj tias nws kawm tag txog qhov no.

Cov tsev saib xyuas menyuam yaus thiab tsev neeg (The department of children and family, or DCF) yuav tsum tau ua qhov yam tsawg tshaj plaws yogi b zaug kev soj ntsuam txog short-term radon. Txawm li cas los xij, kev soj ntsuam cov chaw uas tsis yog tsev nyob, li tsev kawm ntawv, tsev ua haujlwm ces yeej nyuaj thiab tsis yooj yim kaj siab. Nws yog ib lub tswv yim zoo los ntiav ib tus neeg tshaj lij thiab kawm tag txog radon uas paub tias yuav ua li cas thiab kuaj tau zoo. Lawv tuaj yeej muab thiab qhia lub tswv yim ua yog thiab tseeb txog radon, tias [radon muaj ntau](#) npaum li cas nyob hauv qhov chaw ntawd, thiab seb qhov chaw puas muaj kev nyab xeeb.

Lub Tsev zov menyuam

Cov Chaw zov me nyuam

Tus nqi kuaj radon raug yog li cas?

Qhov kev soj ntsuam luv (short-term test kit) tus nqi yog \$10 - \$30 ntawd ib qhov kev soj ntsuam. Tshawb xyuas txog tus nqi ua lawv muab luv lossis pheej yig tau los ntawd koj lub chaw [Radon Information Center](#). Tus neeg soj ntsuam txog radon yuav yuav tus nqi nyob ntawd \$125 thiab \$150 rau kev soj ntsuam txog lub tsev nyob. Qhov chaw Lub chaw zov me nyuam yog lub luag haujlwm rau cov nqi no. Qhov chaw zov me nyuam yog cov uas yuav tau them tus nqi no.

Tus neeg soj ntsuam yuav yuav tus nqi nyob ntawd li \$ 500 txog rau \$ 1500 los kuaj lub tsev nyob menyuam. Tus nqi ntawd kev kuaj radon nyob ntawd se blub tsev loj npaum li cas. Lub chaw zov menyuam yog tus tau them cov nqi no. Txhawm rau kev nrhiav tus kws tshaj lij kuaj ntsuas uas tau kawm tag thiab paub radon, uas yuav pab tau koj hauv koj lub nroog, mus saib hauv [www.lowradon.org](#).

Kuv yuav kuaj ntsuas li cas txog radon ntawd kuv cov chaw (building)?

Kuaj ntsuas radon tsawg kawg yog 48 xuab moo (2 hnuv) hauv qhov chaw qis tshaj hauv lub tsev uas cov menyuam yaus siv sijhawm nyob tsawg kawg yog xya xuab moo ntawd ib lub lim tiam. Lub caij ntuj no yog lub hlis uas zoo tshaj plaws los kuaj ntsuas. Kaw qhov rais thiab qhov rooj thaum kuaj. Xav paub txog kev siv thiab kev taw qhia txog test kit lossis mus rau [www.lowradon.org](#) txog kev paub ntiv ntawd Kev kuaj ntsuas.
