(Billing and Claims Information When Electronic Visit Verification Is Required)



Thaum Wisconsin Department of Health Services (Lub Tuam Tsev Hauj Lwm ntsig txog Kev Pab Cuam Kev Noj Qab Haus Huv) (DHS) tau txais qhov kev thov uas muaj kev xav tau cov ntaub ntawv electronic visit verification (kev txheeb xyuas txog kev tuaj ntsib hauv es lev thos niv) (EVV), lub lab npauv DHS yuav lees paub tias EVV cov ntaub ntawv muaj nyob rau qhov kev thov thiab yuav lees paub cov ntaub ntawv ntawd rau txhua qhov lus qhia ntxaws ntawm qhov kev thov.

Tsuas yog kev mus ntsib EVV uas tau lees paub lawm yog siv los ua kev thov. EVV cov thawj tswj hwm tuaj yeem zam qhov kev ncua sij hawm los ntawm kev lees paub EVV kev tuaj ntsib hauv qhov xwm txheej kev txheeb xyuas hauv Sandata EVV portal (chaw muab kev pab saum huab cua) ua ntej yuav xa qhov kev thov. Cov kws muab kev pab cuam siv lwm lub lab npauv EVV tuaj yeem tshawb xyuas cov xwm txheej ntawm kev tuaj ntsib hauv Sandata lub tshuab khaws cov ntaub ntawv.

Nyeem ntxiv txhawm rau kom paub tias yuav ua li cas yog tias qhov kev thov fee-for-service (tus nqi-rau-kev pab cuam) tsis dhai ib qho ntawm cov kev hloov kho los sis yog tias qhov kev thov raug tsis lees paub vim EVV.

## Cov Lus Nquag Nug Txog Kev Sau Nqi thiab Kev Thov EVV

### Q1. Cov kws muab kev pab cuam yuav qhia tau li cas seb qhov kev thov raug tsis kam lees vim EVV?

A1. Cov kws muab kev pab cuam Fee-for-service (tus nqi-rau-kev pab cuam) yuav tau txais qhov kev tsis kam lees ntawm qhov kev thov txog lawv Remittance Advice (Lub Tswv Yim Pab Txog Kev Xa Nyiaj) nrog cov lus explanation of benefits (lus piav qhia txog cov txiaj ntsig) (EOB). Tsab ntawv EOB ntawm EVV fee-for-service (tus nqi-rau-kev pab cuam) ob tsab ntawv yog:

- #1047 "tsis pon kev tuaj ntsib hauv lub lab npauv EVV."
- #1048, "chav lub lab npauv EVV tsis ua raws li qhov yuav tsum tau ua hauv kev mus ntsib."

Yog tias muaj tsav ntawv EOB uas sib txawv, ces qhov kev thov yuav tsis raug tsis kwm lees paub vim EVV.

Cov neeg muab kev pab cuam tuaj yeem tshaj xyuas cov cai ntawm EOB thiab cov lus piav qhia rau txhua qhov kev thov uas tau xa mus rau ForwardHealth ntawm ForwardHealth Portal (Chaw Muab Kev Pab Saum Huab Cua) ([www.forwardhealth.wi.gov/WIPortal/content/provider/medicaid/EOB\\_Messages.htm.spage](http://www.forwardhealth.wi.gov/WIPortal/content/provider/medicaid/EOB_Messages.htm.spage)).

Tag nrho lwm tus neeg them nyiaj thiab cov kws muab kev pab cuam, suav nrog cov kws tu neeg mob ua hauj lwm ywj pheej, yuav tsum hu rau lawv tus neeg them nyiaj rau cov ntaub ntawv tshwj xeeb hais txog tsab ntawv tsis lees paub thiab xa rov qab thov dua.

Raws li kev ceeb toom, EVV kev tuaj ntsib yuav tsum nyob rau hauv cov xwm txheej kev txheeb xyuas kom haum rau qhov kev thov.

### Q2. Tsab ntawv "Cov Ntsiab Lus Qhia Ntxaws EOBS 1047" txog kev tsis kam lees paub qhov kev thov fee-for-service (tus nqi-rau-kev pab cuam) txhais tau li cas?

A2. EOB 1047, "tsis pon kev tuaj ntsib hauv lub lab npauv EVV" txhais tau hais tias ForwardHealth tsis pom EVV cov ntaub ntawv rau hnub them nqi kev pab cuam. Cov neeg siv lub lab npauv Sandata, EVV tus thawj tswj hwm yuav tsum xav tau kev nkag rau hauv Sandata EVV portal (chaw muab kev pab saum huab cua) thiab siv lub pob taum Visit Maintenance (Kev Tswj Kev Tuaj Ntsib) txhawm rau nrhiaq qhov kev tuaj ntsib. Yog tias tsis muaj kev tuaj ntsib hauv lub lab npauv EVV, lawv tus kheej tuaj yeem tsim qhov kev tuaj ntsib tau. Yog tias muaj kev tuaj ntsib, lawv yuav tau kho txhua qhov kev zam.

Thaum qhov kev zam tau raug hloov kho lawm, los sis qhov kev tuaj ntsib tau raug tsim los ntawm lawv tus kheej lawm, tus thawj tswj hwm yuav tsum paub meej tias qhov kev tuaj ntsib tam sim no nyob rau hauv qhov xwm txheej kev txheeb xyuas. Yog tias ho yog li ntawd, qhov kev thov tuaj yeem xa dua tshiab los tau.

Lwm tus neeg siv lub lab npauv EVV yuav tsum kauj xyuas nrog lawv tus neeg muag khoom EVV txog hloov kho EVV cov ntaub ntawv tuaj ntsib hauv lawv lub lab npauv EVV.

**Q3. Tsab ntawv "Cov Ntsiab Lus Qhia Ntxaws EOBs 1048" txog qhov kev thov uas tsis lees paub txhais tau li cas?**

**A3.** EOB 1048, "chav lab npauv EVV tsis ua raws li qhov yuav tsum tau tuaj ntsib" txhais tau hais tias ForwardHealth pom cov ntaub ntawv EVV rau hnub uas tau txais kev pab cuam, tab sis cov chav EVV tsis sib xws nrog cov chav them nqi. Qhov no yuav tshwm sim thaum qhov kev tuaj ntsib tau luv dua li cov chav them nqi los sis tus kws muab kev pab cuam tau them nqi ntau rau qhov kev tauj ntsib raws li hnub ncua tab sis qhov yuav tsum tau ua rau kev them nqi tsis tau raws li:

- Tus thawj tswj hwm ntawm EVV yuav tsum sib piv cov chav ntawv thov cov nqi them rau chav EVV.
- Yog tias cov chav ntawv thov cov nqi them tsis raug, tus thawj tswj hwm tuaj yeem kho qhov kev thov thiab rov qab xa dua tshiab.
- Yog tias cov chav EVV tsis raug, cov neeg siv lub lab npauv Sandata tuaj yeem kho lawv hauv Sandata EVV portal (chaw muab kev pab saum huab cua) thiab paub meej tias qhov kev tuaj ntsib nyob rau hauv qhov xwm txheej kev txheeb xyuas.
- Lwm tus neeg siv lub lab npauv EVV yuav tsum kauj xyuas nrog lawv tus neeg muag khoom EVV txog hloov kho EVV cov ntaub ntawv tuaj ntsib hauv lawv lub lab npauv EVV.
- Yog tias tus kws muab kev pab cuam siv qhov kev them nqi ua ntu, lawv yuav tsum xyuas kom meej tias tus zauv txheej txheem, tus zauv cov nyiaj tau los, hloov kho, thiab cov chav sau nqi yog tib yam rau txhua hnub hauv ntu.
- Thaum cov ntaub ntawv sau nqi qhia ntxaws zoo ib yam li los sis tsawg dua li cov chav EVV thiab qhov kev tuaj ntsib tau txheeb xyuas hauv Sandata, qhov kev thov tuaj yeem rov qab xa dua tshiab.

**Q4. Thawj kauj ruam ntawm kev xa qhov kev thov uas raug tsis lees paub vim EVV yog dab tsi?**

**A4.** Ua ntej rov qab xa daim ntawv tsis lees paub, tus kws muab kev pab cuam fee-for-service (tus nqi-rau-kev pab cuam) siv lub lab npauv Sandata yuav tsum ua kom paub tseeb tias EVV cov ntaub ntawv tuaj ntsib yog raug thiab raug txheeb xyuas hauv Sandata EVV portal (chaw muab kev pab saum huab cua).

Lwm tus neeg siv lub lab npauv EVV yuav tsum kauj xyuas nrog lawv tus neeg muag khoom EVV txog hloov kho EVV cov ntaub ntawv tuaj ntsib hauv lawv lub lab npauv EVV.
