

Wisconsin Marriages and Divorces, 1999

Introduction

This report presents key information about marriages and divorces that *occurred* in Wisconsin in 1999. It also contains information from selected previous years, as well as information on the number and rate of marriages and divorces, both in Wisconsin and nationally. The sources of data for Wisconsin are marriage and divorce certificates on file with the Bureau of Health Information, Division of Health Care Financing, Department of Health and Family Services.

The collection of marriage and divorce data is mandated by Chapter 69 of the Wisconsin Statutes. Chapter 69 authorizes the Department of Health and Family Services to supervise and direct the collection of these data. This statute also stipulates how local registrars are to collect and file certificates of marriage. Samples of the marriage and divorce certificates are included in the Technical Notes.

The Bureau of Health Information would like to thank the County Clerks for issuing accurate marriage licenses and the local Register of Deeds offices for their accurate recording of all marriage records.

The Department of Health and Family Services produced this publication. Staff of the Vital Records Registration and Statistics Unit, Bureau of Health Information, collected and compiled the marriage and divorce records. Joyce Knapton drafted the summaries in this report and produced the computer programs to generate the tables. Jane Kraus supervised data collection activities, and Patricia Nametz edited the report. The report was prepared under the overall direction of Barbara Rudolph, Director, and Sandra Breitborde, Deputy Director, Bureau of Health Information.

Key Findings

- A total of 35,754 marriages occurred in Wisconsin in 1999, representing a slight increase from the 34,946 marriages that occurred in 1998. These counts reflect all marriages that occurred in Wisconsin (of both residents and non-residents of the state).
- Wisconsin's marriage rate in 1999 was 6.8 per 1,000 total population, similar to the 1998 rate (6.7) but still part of a gradual decline since 1980 (when the rate was 8.7).
- The marriage rate in Wisconsin has been consistently lower than the national rate for more than 75 years. In 1999, the United States marriage rate was 8.4.
- For the past three years, the median age at first marriage has remained the same (24.6 for brides and 26.3 for grooms). In 1960, the median age at first marriage was 20.4 for brides and 22.9 for grooms.
- Since 1960, the average bride in a first marriage has been approximately two years younger than the groom.
- In 1999, the months with the highest number of marriages were June, September and October. September was the most popular month to marry.
- Milwaukee County had the highest number of marriages in 1999 (5,547), followed by Dane County (2,769), Waukesha County (2,333), and Brown County (1,644). These are Wisconsin's four most populous counties.
- A total of 17,302 divorces occurred in Wisconsin in 1999, for a divorce rate of 3.3 per 1,000 total population. This is identical to the 1998 rate, which was the lowest statewide rate since 1975.
- The divorce rate in Wisconsin has been consistently lower than the national rate for more than 75 years. In 1999, the United States divorce rate was 4.2.
- In 1999, the total number of Wisconsin divorces was 48 percent of the total number of Wisconsin marriages. This is down two percentage points from 1998.
- The highest number of divorces occurred in Milwaukee County (2,593 divorces and 14 annulments), followed by Dane County (1,347 divorces and 7 annulments) and Waukesha County (1,019 divorces), reflecting the large populations of these three counties.
- Fifty-seven percent of all Wisconsin divorces in 1999 involved families with children under 18 years of age. Among divorces involving families with children, an average of 1.8 children were affected by each divorce.

The numbers in this table reflect all marriages that occurred in Wisconsin in the stated years.

Technical Notes

Marriage Reporting Requirements

As specified in Chapter 69, Wisconsin Statutes, the following is a brief outline of the sequence of events which take place when a marriage occurs in Wisconsin:

- The filing party (officiant) must register the certificate of marriage with the local Register of Deeds (where the marriage took place) within 3 days after the event.
- The local Register of Deeds must transmit the marriage certificate to the State Registrar within 10 working days after its receipt.

A sample marriage certificate form can be found on page 16.

Divorce Reporting Requirements

As specified in Chapter 69, Wisconsin Statutes, the following is a brief outline of the sequence of events which take place when a divorce occurs in Wisconsin:

- At the end of every biweekly period the filing party (clerk of any court) must send to the State Registrar a report of every divorce or annulment of marriage granted during that period. (This is the only legal document pertaining to vital records that is not filed by the local Register of Deeds.)
