Indication

For people with general oral supplement needs, increased protein requirements (such as, wound healing, cancer, surgery), inadequate oral intake, and malnutrition. Not WIC-allowed for managing body weight without an underlying medical condition.

Milk-based, high protein nutritional supplement to support muscle health. Can be supplemental or interim sole source nutrition.

Indication

For infants who have protein maldigestion, malabsorption, severe food allergies, short bowel syndrome, eosinophilic GI disorders, GI impairment, or other qualifying conditions in which a health care provider recommends this nutrition source.

Description

Nutritionally complete, amino acid-based, hypoallergenic infant formula for dietary management of infants with severe cow's milk protein allergy.

- Standard Dilution: 20 calories per ounce and 33% MCT oil. 1 scoop to 2 ounces water.
- Contains DHA/ARA fatty acids

Indication

For children who have protein maldigestion, malabsorption, severe food allergies, short bowel syndrome, eosinophilic GI disorders, GI impairment, or other conditions in which an amino acid-based diet is required.

Description

Nutritionally complete, amino acid-based, hypoallergenic infant formula for dietary management of children with severe cow's milk protein allergy.

- Not recommended for infants with a post-pyloric feeding tube which bypasses the stomach and empties into the small intestine
- Not recommended for infants with a central venous catheter (CVC)
- Not recommended for infants with short bowel syndrome

Nutritionally complete, amino acid-based, hypoallergenic infant formula. Same as Neocate Infant but contains Syneo blend of prebiotics and probiotics.

Nutritionally complete, extensively hydrolyzed formula. Contains casein hydrolysate (milk byproduct), a pork-derived enzyme, which may make product unacceptable to participants who observe certain religious dietary laws.

- Contains DHA/ARA fatty acids
- Lactose, sucrose, galactose free

Indication

For infants and children with symptoms of a cow's milk or soy allergies, multiple food allergies, related GI or allergic conditions or other qualifying conditions in which a health care provider recommends this nutrition source.

Description

Nutritionally complete, extensively hydrolyzed formula. Contains casein hydrolysate (milk byproduct), a pork-derived enzyme, which may make product unacceptable to participants who observe certain religious dietary laws. Contains LGG (Lactobacillus Rhamnosus GG), a probiotic, which helps support the strength of the intestinal barrier and digestive health.

- Standard Dilution: 20 calories per ounce, 1 scoop to 2 ounces water
- Contains DHA/ARA fatty acids
- Concentrate and Ready to Feed do not contain LGG (probiotic)
- Lactose, sucrose, galactose free
