Minutes

Call to Order:

Committee Co-Chairperson Christine Ullstrup called the meeting to order at 9:36 a.m. Attendees introduced themselves.

Review of 10/3/2018 Meeting Minutes:

Christine Ullstrup referenced the draft minutes from the October 3, 2018 Committee meeting and asked for comments and corrections. Christine clarified language regarding comments she had made noting the upcoming November election. Kevin Florek moved that the minutes be approved and Jill Gamez seconded the motion. Motion carried unanimously.

Public Comment:

No persons offered any public comment on Committee business via telephone. Vonda Benson mentioned that her last day with Department of Corrections (DOC) is Dec. 21st, as she is retiring. Her replacement at DOC will start in January, and hopefully be able to serve on the Committee. Kevin Florek asked the group what the impact of Tony Evers' election as Governor would be on SCAODA and its committees, and a discussion ensued.

New Committee Members and Expectations:

Committee members reviewed the draft handout listing the committee description, duties and responsibilities of members, member composition, required knowledge and skills, and what committee members will commit to. Comments regarding additions and suggested language revisions were offered by Kevin Florek, Raeanna Johnson, Jill Gamez and Christine Ullstrup. Florek suggested that the criteria language for member composition be left broad, but that members have the freedom to recruit persons meeting a specific background to fill a Committee need. Gamez offered language to insert into the Committee Description paragraph. Mike Derr will incorporate the suggested changes and comments into an updated draft, to be reviewed at the 1/16/09 meeting.

2018-22 Strategic Plan - Committee Priorities for 2019:

Committee members discussed the desire to establish priorities and activities for 2019 that are consistent with the recently-approved SCAODA 2018-22 Strategic Plan. Many suggestions for topics and activities to study and offer recommendations on were shared by committee members and staff:

- Jill Gamez stated that the Committee should study issues that are most likely to be considered during the 2019 legislative session. Christine Ullstrup added that the Committee should closely monitor legislation and work with Roger Frings and Council leadership to meet with legislators to advocate for and promote specific actions. Jill offered to write up an action plan draft based on the Council's 2018-22 Strategic Plan and P&F Committee objectives.
- Mike Derr alluded to Duncan Shrout's previous suggestion that the Committee study various funding sources and recommend how funding should be allocated geographically and among various programming. The Committee's 2016 Funding Report would be of assistance in this realm.
- Raeanna Johnson and Brian Dean stated that the Committee should develop a stripped down version of the most recent needs assessment and offer recommendations for specific areas of focus, such as residential treatment. These reports would be offered to the full Council and Legislature to take action. Johnson also referenced the PEW reports for the Committee to adopt recommendations from. Mike Derr noted that DHS will start developing the next SUD needs assessment during 2019 as part of the next SABG application and plan.
- Other topics mentioned included closely monitoring the new Medicaid waivers that will expand coverage over residential treatment and other services, and working closely with the Governor's Opioid Task Force and whatever form this body takes under Governor Evers.

Action Steps by Committee Members:

At this point, Christine Ullstrup and Mike Derr asked individual Committee members to start taking on specific projects or tasks for the purpose of addressing and meeting the above-stated priorities:

- Jill Gamez will review and summarize the Minnesota administrative code counterpart to DHS 75, including an explanation of its three levels of care.
- Committee members should read and review the 2017 Needs Assessment, the Committee's 2016
 Funding Report, and the PEW Study recommendations, and be prepared to discuss specific
 recommendations and areas of focus in January and subsequent committee meetings. Raeanna Johnson
 will take the lead on pulling together key concepts from those documents, with assistance from Brian
 Dean and Kevin Florek.
- Mike Derr will keep Committee members informed and updated on the 2019 Needs Assessment process, including opportunities for members to provide input and feedback.
- Christine Ullstrup, Jill Gamez and Mike Derr will keep Committee members updated on the DHS 75 rulemaking rewrite process.
- Mike Derr will work with the DHS evaluation team to create a polished one-page summary of the residential SUD treatment bed survey findings and potential follow-up surveys.
- Christine Ullstrup and Roger Frings will identify key stages, dates and personnel in the state legislative and budget processes to promote effective Committee and Council advocacy of specific legislation and policies.

- Mike Derr and Karen Kinsey will communicate with Dan Kiernan of the DHS Medicaid office and track current efforts to expand Medicaid coverage across residential treatment and other areas, and promote opportunities for Committee member and stakeholder involvement. Christine suggested that the Council be asked to issue a statement supporting the expansion of MA coverage and encouraging stakeholder and Committee participation in the waiver approval and rate setting process.
- Mike Derr and Committee members will seek information regarding specific Medicaid rates covering CCS (Comprehensive Community Services) services, including room and board.
- Christine Ullstrup felt it would also be beneficial to further explore current Department of Corrections initiatives relative to SUD services. For example, DOC's Division of Community Corrections regional offices have invited Meta House and other treatment providers discuss their services to staff.

Other Topics:

Committee members reviewed the proposed six meeting dates for 2019. Members jointly agreed that given the amount of upcoming action steps and projects, the Committee should hold eight meetings, including meetings in April and August. Also, the group decided to schedule meetings for the third Wednesdays during the months of Jan., Feb., April, May, July, Aug., Oct and Nov. Meetings will continue to occur from 9:30 a.m. to Noon at the ARC Community Services building on Emil Street in Madison.

Mike Derr gave a brief summary of the SCAODA Public Forum held during the Fall Mental Health & SUD Recovery Conference in WI Dells on October 17th. A written summary of the forum discussion was shared with Committee members.

Christine Ullstrup and Jill Gamez mentioned possible candidates who are interested in serving on the Committee. Mike Derr will send them a description of committee and updated version of the committee description and member expectations.

<u>Adjournment</u>: A motion to adjourn the meeting was made by Brian Dean and seconded by Raeanna Johnson. Motion carried. Meeting adjourned at 12:01 pm.

SCAODA Planning and Funding Committee Members [1.9.19 Draft]

Committee Description:

The Committee focuses on coordinating substance use disorder (SUD) planning and funding initiatives across the state. Specifically, the committee identifies pertinent issues in the field of SUD prevention and treatment; reviews legislation pertaining to alcohol and other drugs, providing educational materials to legislators; assess the capacity of SUD programming to meet the needs of the public, reduce duplication and promote efficiencies; and develop and submit motions that set forth recommendations, for full Council consideration, that relate to SUD funding and planning policies.

Major Duties and Responsibilities:

- Adhere to the State Council on Alcohol and Drug Abuse (SCAODA) by-laws
- Be an active participant in the goals and objectives of the committee
- Attend majority of scheduled meetings
- Work on sub-committees to fulfill goals and objective and report back to P&F committee on progress
- Sit on committee for a term of at least two years
- Keep abreast of changes and trends in the field or professions relevant to committee's work

Committee Member Composition:

- Committee Chair is a member of SCAODA
- One or more Prevention Specialist
- One or more Treatment and/or Recovery Specialist
- One or more member with executive/administrative/planning experience
- One or more county or tribal program specialist or administrator
- One or more member has experience with grant funding and/or state budget
- One or more member each from a minimum of two state agencies beyond DHS (i.e., Department of Corrections, Department of Public Instruction)
- In addition, the committee will strive for a committee membership with geographic balance across the five DHS Area Administration regions.

Required Knowledge, Skills and Abilities:

- Past and present civic commitment, activities and positions related to SUD
- Vision on how committee and SCAODA would benefit from your involvement
- Experience in executive oversite of planning and funding, meeting long-term needs
- Strong interpersonal skills ability to work within a group
- Excellent oral and written communication skills
- Highly energetic, self-motivated individual with desire to serve and act

- Passion for advocating and influencing the SUD field to improve welfare across the state
- Forward thinker, creative

The Chairperson/Co-Chairperson shall

- Be responsible for overseeing motions that are passed and business of the committee are acted upon in an orderly and expeditious manner assuring that rights of members are recognized.
- Appoint a designee to preside at a meeting if he/she is unavailable
- Be responsible to work with DHS assigned staff to schedule meeting, set agendas and organize the work of the committee
- Work with DHS staff to coordinate logistics of meeting and disseminate meeting information, minutes and notices.
- Attend or have designee attend SCAODA meetings and prepare a report on P&F Committee business

To: Adult Mental Health Day Treatment Providers, Advanced Practice Nurse Prescribers with Psychiatric Specialty, Child/Adolescent Day Treatment Providers, Crisis Intervention Providers, Community Support Programs, Comprehensive Community Service Providers, HMOs and Other Managed Care Programs, Intensive In-Home Mental Health and Substance Abuse Treatment Services for Children Providers, Master's-Level Psychotherapists, Outpatient Mental Health Clinics, Outpatient Substance Abuse Clinics, Psychiatrists, Psychologists, Physician Clinics, Physicians, Qualified Treatment Trainees, Substance Abuse Counselors, Substance Abuse Day Treatment Providers

Coverage of Residential Substance Abuse Treatment by Comprehensive Community Services Providers

Effective for dates of service on and after May 1, 2017, county and tribal comprehensive community services programs may be eligible to receive Medicaid reimbursement for providing substance abuse treatment in medically monitored treatment service facilities and transitional residential treatment service facilities.

Overview of Expanded Services

Effective for dates of service on and after May 1, 2017, county and tribal comprehensive community services (CCS) programs may be eligible to receive Medicaid reimbursement for providing substance abuse treatment in medically monitored treatment service facilities (Wis. Admin. Code § DHS 75.11) and transitional residential treatment service facilities (Wis. Admin. Code § DHS 75.14).

Member Eligibility

Medicaid or BadgerCare Plus members enrolled in CCS may receive residential substance abuse treatment services through the CCS program as long as the members meet the following criteria:

 Admission criteria established in Wis. Admin. Code ch. DHS 36 and § DHS 75.11 or 75.14

- Program requirements outlined in the Program
 Requirements topic (topic #17117) of the Covered
 Services and Requirements chapter of the Covered and
 Noncovered Services section of the Comprehensive
 Community Services service area of the ForwardHealth
 Online Handbook
- The services are determined necessary through the CCS assessment and service planning process

Covered Services

Residential substance abuse treatment services are being added as covered services within the CCS program service array. Residential substance abuse treatment can include any service described on the CCS program service array delivered in accordance with all CCS program requirements. Examples include:

- Screening and assessment
- Service planning
- Diagnostic evaluations
- Medication management
- Physical health monitoring
- Peer support
- Individual skill development and enhancement

Department of Health Services

- Employment-related skill training
- Individual and/or family psychoeducation
- Recovery support services
- Substance abuse treatment

ForwardHealth only covers services described in the Covered Services and Requirements chapter of the Covered and Noncovered Services section of the Comprehensive Community Services service area of the Online Handbook. Services must be provided by qualified staff who meet the minimum qualifications per Wis. Admin. Code § DHS 36.10(2)(g).

Noncovered Services

The list of services not covered under the CCS benefit remains in effect as described in the Noncovered Services topic (topic #17157) in the Noncovered Services chapter of the Covered and Noncovered Services section of the Comprehensive Community Services service area of the Online Handbook.

As a reminder, the following are not covered by BadgerCare Plus and Wisconsin Medicaid for CCS programs:

- Room and board
- Costs for services provided in an Institution for Mental Diseases (IMD)
- Services that are not rehabilitative, including services that are primarily recreation-oriented
- Job development activities related to finding a member a specific job

Note: An IMD is an institution of more than 16 beds that is primarily engaged in providing diagnosis, treatment, or care of persons with mental disease (including substance use disorders). Any medically monitored treatment service or transitional residential treatment service of 17 or more beds is categorized as an IMD and may not be covered through the CCS program.

Program Requirements

To be eligible for reimbursement, residential substance abuse treatment provided through CCS must meet the program requirements found in the Program Requirements topic

(topic #17117) of the Online Handbook. Additionally, the services must:

- Be provided in a medically monitored treatment service facility or transitional residential treatment service facility certified by the Division of Quality Assurance per Wis. Admin. Code §§ DHS 75.11 and 75.14.
- Be provided by licensed/certified staff acting within his or her scope of practice.

The CCS program, as the Medicaid-enrolled provider, assumes legal and fiscal responsibility for the services provided by contracted residential services. The CCS program is responsible to ensure that contractors are qualified to provide services, meet all program requirements and maintain records in accordance with the requirements for the provision of services. ForwardHealth sends provider materials to Medicaid-enrolled providers only and providers are required to ensure contractors are informed and receive copies of ForwardHealth Updates.

Medicaid requirements for CCS programs do not relieve medically monitored treatment service or transitional residential treatment service facilities of their own regulatory requirements. These services are required to continue to meet the standards established in Wis. Admin. Code ch. DHS 75, including, but not limited to, operations, personnel, admission, and documentation requirements.

Claims Submission

When submitting claims for residential substance abuse treatment, CCS providers are required to follow the same requirements as they do when billing for other CCS programs. For general claims submission requirements, refer to the Claim Submission for Comprehensive Community Services topic (topic #17219) of the Submission chapter of the Claims section of the Comprehensive Community Services service area of the Online Handbook.

Like other CCS services, time spent providing residential substance abuse treatment is required to be documented in 15-minute service units. The per-unit method for billing residential CCS services takes into account members receiving a combination of individual and group services in a

residential environment, which is documented in the member's service record.

As a reminder, staff do not need to document every 15-minute interval for all CCS members in a day. However, staff are required to document the total service time provided to a CCS member, rounded to the nearest 15-minute increment.

Note: Certified CCS programs retain all legal and fiscal responsibility for CCS — including those provided via contract. A CCS provider is required to ensure contractors meet all program and documentation requirements and remain current in their understanding of applicable ForwardHealth policy.

Reimbursement

There is no change in the process for receiving reimbursement when providing residential substance abuse treatment services. As a reminder, only CCS providers will submit claims to Wisconsin Medicaid. Reimbursements made to medically monitored treatment service providers (Wis. Admin. Code § DHS 75.11) and transitional residential treatment service providers (Wis. Admin. Code § DHS 75.14) will be based on their contracts with the CCS providers.

Section 1115 BadgerCare Reform Demonstration Waiver

Rewarding Work: BadgerCare Reform

The Department of Health Services (DHS) has launched the application process for the Section 1115 BadgerCare Reform Demonstration Waiver Amendment, which includes policy changes aimed at helping more people move from government dependence to true independence by encouraging work and providing incentives for healthy lifestyles. Amendments to the Section 1115 demonstration waiver, known as the BadgerCare Reform Demonstration Waiver, are reforms that build on Governor Scott Walker's "Wisconsin Works for Everyone" initiative, aimed at helping more people move into employment. These reforms affect nonpregnant adults without dependent children who are mentally and physically able to work and who are receiving government-funded health care benefits. It also assists BadgerCare Plus members who are battling addiction. The reforms are based on changes in state law under 2015 Wisconsin Act 55. DHS must obtain approval from CMS before these changes can take effect.

Section 1115 demonstrations and waiver authorities in Section 1915 of the Social Security Act are vehicles states can use to test new or existing ways to deliver and pay for health care services in Medicaid and the Children's Health Insurance Program (CHIP). <u>Learn more about all current and concluded state programs authorized under these authorities</u>.
