Rov Thov Dua Kom Zam Txoj Cai (Waiver Renewal)

- Governor Walker tau tshaj tawm daim phiaj muab kev kho mob Health Care Stability Plan thaum January 2018.
- Governor Walker daim phiaj tau thov kom muab qhov waiver tas mus li los pab txhawb SeniorCare.
- Waiver cov kev pab cuam yuav muab kev yooj yim ntxiv rau cov xeev los mus tsim thiab kho lawv cov kev pab cuam kom zoo dua qub.

Rov Thov Dua Kom Zam Txoj Cai (Waiver Renewal), txuas ntxiv

- Thaum xub thawj, cov waivers tau tso cai txog tsib lub xyoos thiab yuav ncuu tau sij hawm ntxiv peb lus xyoos mus rau 10 xyoos.
- Cov waivers no tsis yog ib qho kev pab cuam uas yuav muaj nyob ntawd tas mus li.
- Lub Department of Health Services (DHS) tau xa ib daim ntawv mus thov kom muab qhov waiver ntev mus txog 10 lub xyoos. Qhov no yog ib lub sij hawm ntev tshaj plaws uas tau tso cai nyob hauv tsoom fwv cov cai.

SeniorCare muab nyiaj pab them rau cov nqi tshuaj rau cov neeg nyob hauv Wisconsin uas muaj hnuv nyoog 65 xyoos thiab tshaj saud uas lawv cov nyiaj tau los nyob rau ntawm los yog qis dua 200 feem pua ntawm tsoom fwv tus ciam ntsuas cov tseem txom nyem (federal poverty level, FPL) thiab tsis tau txais Medicaid cov nyiaj pab them.

Keep Kwm Yav Dhau Los Ntawm Waiver

- Thaum July 1, 2002, CMS tau pom zoo qhov waiver rau DHS los mus khiav ib feem ntawm SeniorCare mus tsib xyoos kom pom seb txoj hauj lwj mus tau li cas. Qhov waiver no tau tas sij hawm thaum June 30, 2007.
- Hauv xyoo 2006, DHS tau ua ntawv thov kom ncuaj sij hawm ntxiv rau qhov waiver los mus pib thaum July 1, 2007; CMS tau tsis kam lees muab sij hawm ncuaj ntxiv. Tsoom fwm tsab cai (bill) muab nyiaj ntxiv muaj ib nqe lus los muab waiver mus ntxiv kom mus txog December 31, 2009.

Medicare Part D Cov Lus Tseem Ceeb

- Medicare Part D tseem pab them rau cov tshuaj rau cov neeg mob tsis pw kho tus mob rau cov muaj hnuv nyoog uas muaj Medicare.
- Standard Part D tus nqi sib pab them (cost sharing) muaj xws li:
 - Cov nqi them (premiums) txhua hlis, uas yog them ntau raws li qhov nyiaj tau los.
 - Feem yus them ua ntej (deductible) txhua xyoo, uas tsis tshaj \$405 hauv xyoo 2018 thiab \$415 hauv xyoo 2019.
 - Coverage gap, kheev muab hu tias yog donut hole, uas tab tom muab rho tawm tsis muaj ntxiv lawm.
