## Lub Plaub Hlis Ntuj 2024

Hais los ntawm Wisconsin Department of Health Services (Lub Tuam Tsev Hauj Lwm ntsig txog Cov Kev Pab Cuam Kev Noj Qab Haus Huv), Division of Public Health (Feem Hauj Lwm ntsig txog Pej Xeem Kev Noj Qab Haus Huv), thiab peb Tobacco Prevention and Control Program (Lub Khoos Kas Tiv Thaiv thiab Tswj Xyuas Luam Yeeb). Kuv tab tom sau tsab ntawv no ua tsaug rau txhua lub khw me muag luam yeeb thiab luam yeeb hluav taws xob hauv Wisconsin uas tau saib xyuas kom ua raws li tsoom fwv teb chaws Luam Yeeb 21 teev hnuv nyoog muag yam tsawg kawg nkaus raws li txoj cai lij choj hauv peb lub xeev.

**Txoj cai lij choj teev hnuv nyoog muag yam tsawg kawg nkaus raws li tsoom fwv teb chaws txoj cai lij choj tej yam yuav hloov lub xeev txoj cai lij choj uas sib txawv nyob rau hauv lub Teb Chaws Meskas.** Qhov no muaj tseeb nyob rau hauv Wisconsin, uas lub xeev txoj cai lij choj kev muag luam yeeb thiab luam yeeb hluav taws xob, uas tau teev cia ntawm hnuv nyoog 18 xyoo, tseem tsis tau hloov kho kom haum rau tsoom fwv teb chaws txoj cai lij choj, teev cia ntawm hnuv nyoog 21 xyoos. Kom paub meej, tam li yog Wisconsin cov khw me muag luam yeeb thiab/los sis luam yeeb hluav taws xob, koj yuav tsum ua raws li tsoom fwv teb chaws txoj cai lij choj Luam Yeeb 21.

**Food and Drug Administration (Kev Tswj Tshuaj thiab Khoom Noj Khoom Haus) (FDA) cov kws tshuaj ntsuam xyuas cov khw me muag luam yeeb nyob thoob plaws Wisconsin rau kev muag cov khoom tsis muaj hnuv nyoog.** Dhau ntawv lawm FDA kuj tseem ua hauj lwm rau pej xeem kom tshaj tawm txog kev muag luam yeeb tsis muaj hnuv nyoog thiab/los sis kev tshaj tawm thiab kev lo paib tsis raug, uas tuaj yeem pib qhov kev mus saib koj qhov chaw muag khoom yam tsis qhia rau paub ua ntej los tau. FDA tawm ib tsab cai nplua nyiaj rau pej xeem txog li ntawm \$10,000.

**Peb nkag siab tias koj thiab koj lub lag luam vam khom cov neeg ua hauj lwm muag khoom thiab cov neeg ua hauj lwm hauv khw kom ua raws li txoj cai lij choj kev muag khoom Luam Yeeb 21.** Yog vim li no, peb muaj cov cuab yeej cob qhia pub dawb nyob hauv oos lais ntawm witobaccocheck.org rau koj cov neeg koom tes los kawm txog lub hnuv nyoog muag yam tsawg kawg nkaus raws li txoj cai lij choj hauv Wisconsin, sim lawv qhov kev paub, thiab tau txais daim ntawv pov thawj kev cob qhia. Wisconsin txoj cai lij choj hais kom cov khw me muag khoom qhia lawv cov neeg ua hauj lwm txog cov cai lij choj muag luam yeeb thiab luam yeeb hluav taws xob.

**Nws ua rau muaj qhov sib txawv loj npaum li cas ntawm ib tus neeg twg uas pib siv luam yeeb thiab tshuaj nicotine thaum hnuv nyoo twg.**

Cov tub ntxhais hluas thiab cov hluas muaj kev cuam tshuam tshwj xeeb rau qhov tsis zoo ntawm tshuaj nicotine rau lawv txoj kev noj qab haus huv thiab kev loj hlob ntawm lub hlwb, thiab cov teeb meem no tuaj yeem caum lawv mus txog rau thaum laus. Thaum peb ua hauj lwm ua ke, peb tuaj yeem pab txhua tus neeg pej xeeb hauv Wisconsin kom muaj kev noj qab nyob zoo, lub neej zoo dua qub tuaj.
