### Background

The Wisconsin American Indian Health Project Grant funding is designated through [Wis. Stats. s. 20.435 \(1\) \(ke\)](#) and described in [Wis. Stats. s. 250.20\(5\)](#).

### Generalized Funding Statement

The allocation of \$106,896 is distributed to the 11 tribal nations and the Great Lakes Inter-Tribal Council.

### Scope of Work Summary

The goal of this funding is to assist in developing, testing or demonstrating solutions for specific American Indian Health problems. Activities may include, but not limited to, the following:

- Conducting community health care needs assessments and studies related to American Indian health care issues.
- Increasing the partnership among inter-tribal departments, county/local public health, human services and other agencies, tribal and non-tribal members, businesses, schools, and so forth, to work together on achieving improved population-based spiritual, mental, and physical community health outcomes.
- Creating awareness and sharing culturally-based holistic, healing knowledge within programs and community initiatives in addressing the historical trauma, current health issues, strength and resilience of the tribal nation.
- Teaching tribal nation history, language, and indigenous foods and medicines to children and adults.
- Implementing strategies to prevent or reduce injury.
- Creating awareness and an action group concerning Missing and Murdered Indigenous Women.
- Providing innovative community-based health care services to American Indians.
- Funding start-up costs of programs to deliver health care services to American Indians.
- Utilizing evidence based and indigenous best practice strategies to promote mental health among youth.
- Increasing the engagement of non-physician team members (e.g. community health workers, nurses, pharmacists, community members/groups) in strategies to prevent drug and alcohol abuse.
- Creating awareness and culturally-congruent programs in the prevention of chronic and infectious disease using best or evidence-based practices.
- Increasing access to dental screening for pre-school and elementary aged children.
- Providing fluoride varnish for pre-school aged children.
- Increasing breastfeeding rates in the community.
