### Background

The DHS AODA Treatment allocation is from the federal funding of Substance Abuse Prevention and Treatment Block Grant (SAPTBG). The SAPTBG fund is to be used for planning, implementing, and evaluating activities to prevent and treat substance use disorder. This additional fund is for tribes to provide AODA treatment services for the target group of alcohol and/or drug abusers. The funding must be used on primary AODA treatment activities. All guidelines of the SAPTBG must be followed in spending these funds.

#### **Generalized Funding Statement**

The total of this fund is \$21,800. This fund is to be distributed to three tribes. Lac du Flambeau receives \$7,266; Potawatomi receives \$7,267; and \$7,267 goes to Sokaogon. The contract runs from **October 1, 2023 through September 30, 2024**. The SAPTBG requires tribes to serve women and women with dependent children.

#### Scope of Work Summary

- Funding for the Tribal AODA Treatment program must be used for primary Tribal AODA treatment activities for the tribes.
- At least 10 percent must be expended for programs and services designed for women and women with dependent children.
- The remainder of the fund can be spent for substance use disorder treatment and recovery support services.
- Pregnant women must be given priority in treatment admissions.
- Treatment programs must directly (or through arrangements) make tuberculosis services available to everyone who receives treatment.
- This fund must be used as the payment of last resort for services for pregnant women, women with dependent children, TB services, and HIV services.
- Report all AODA treatment activities into PPS in a timely manner.

## Restrictions on spending SABG funds

- Funds cannot be used to provide inpatient hospital services (there are limited exceptions).
- Funds cannot be used to make cash payments to intended recipients of health services.
- Funds cannot be used to buy or improve land; purchase, construct, or permanently improve any building; or buy major medical equipment.
- Funds cannot be used for the expenditure of non-federal funds as a condition for the receipt of federal funds.
- Funds cannot be used to provide financial assistance to an entity other than a public or nonprofit private entity.
- Funs cannot be used to provide individuals with hypodermic needles or syringes so that such individuals may use illegal drugs.
- Funds cannot be used to provide treatment services in penal or correctional institutions.
- Funds cannot be used to provide early intervention services for HIV.
