\*Though this report uses the term “breastfeeding” and “breastfed”, we recognize that not all lactating people use the terms “breastfeeding/breastfed.” Some people may exclusively pump their milk without feeding directly from the breast, and chestfeeding and bodyfeeding are other ways to describe the feeding of human milk to a child. Data on breastfeeding participants is inclusive of all breastfeeding, chestfeeding and human milkfeeding individuals who were participating in the program including women, transgender men and nonbinary-gendered individuals.
