## Meeting Call to Order, presented by Heather Bruemmer

- All council members introduced themselves
- Approval of March 2021 Minutes
  - Motion to approve by Dennise Lavrenz. Seconded by Janet Zander. Unanimously approved

#### Department Updates, presented by Carrie Molke and Curtis Cunningham

- Division of Public Health (DPH)
  - COVID
    - State received grants
      - State long term care ombudsman is receiving funding
      - Waiting for what amount is coming to Wisconsin for Adult Protective Services (APS)
      - Vaccine outreach and coordination program
        - all that applied for funding will be receiving it (ADRCs and tribes)
      - Independent living centers, 6 out of 8 will receive vaccine funding.
      - Office of blind and visually impaired are almost ready to begin their in person services
  - Coalition to end isolation and loneliness
    - Survey sent out to see who is interested in joining to one of the four groups
      - Public awareness
      - Research and data
      - Detecting and responding
      - Advocacy and public policy
    - Survey link will be sent to council members
    - Anyone can sign on to the coalition at any time
    - Small group of 10 leading this coalition
  - Dementia
    - Five-year state plan that looks at five core areas
      - Workgroup for each core area
    - Currently revisiting strategies
    - Looking to open to others to join dementia work that have an interest in it.
  - Every three years, State, local and Tribal agencies, and AAAs, beginning process of aging plans
    - This year, counties and tribes are developing their's first and state last so state can learn from local counties and tribes as they get input.

#### F-01922

- Local aging units will be required to have an aging plan goal to work on racial justice/equality
- Division of Medicaid Services (DMS) Updates
  - Electronic Visit Verification (EVV)
    - Continuing to move forward and implementing the systems
    - There have been issues with aggregation for those not using state provided system
      Working to correct this
    - Working towards CMS required hard launch, currently scheduled for November 2021
  - American Rescue Plan Act (ARPA)
    - 10% match for Home and Community Based Services (HCBS) services for 1 year
      - Waiting for CMS guidance for what this can be used for
    - Nursing home strike teams, Renee Eastman and Krista Willing are leading this
    - Matching funds for COVID related services
    - Suggestions for what funding used for include Jim Jones and Chuck
    - Council Suggestions
    - One-time funds would allow for robust evaluation of rate bands
  - Children's Long Term Support (CLTS) waiver
    - Approved by the Joint Finance Committee (JFC)
    - Out for public comment
  - Monthly Rate of Service (MROS)
    - Conversations continuing and looking at data received
    - Talking with the ICAs
    - Grant Cummings is new Bureau Director for the Bureau of Rate Setting
      - Will be working with Krista Willing on this
  - Home and Community Based Services (HCBS) Statewide Transition Plan (STP)
    - This summer, STP will be out for public comment
    - Heightened scrutiny settings were sent to CMS recently
      - Were out for public comment prior
    - Managed Care Quality Strategy is out for public comment until 5/21 (send link)
  - Non-Emergency Medical Transportation (NEMT)
    - More will be presented on this later in today's meeting
    - This is used for IRIS and other Medicaid recipients (not Family Care members)
    - Current broker is MTM
    - New broker is Veyo potentially start on November 1, 2021

## Workforce Discussion presented by Carrie Molke

- Went through PowerPoint
- Discussed Council Charge
- Link will be sent to council members for Wisconsin Caregivers in Crisis by Governor's Task Force on Caregiving
- Teal recommendations in PowerPoint are in the JFC version of the budget
- Nursing home and personal care payment reform some of this stayed in the budget, what was removed were statutory regulations that directed the methodology by which nursing homes were paid
- Concerns noted is that governor's task force was structured differently and met more frequently than the LTCAC
- Will be adding about 3 from taskforce to joining LTCAC
- There is not a single more important issue that is going to affect our LTC/HCBS system going forward. And where people are going to come from that are going to provide care. Paid and unpaid workforce

- Council Suggestions:
  - Make sure you integrate diversity on this when moving the charge into LTCAC, need different voices and background
  - At next meeting could each council member submit their recommendations to have a starting point to make the task more manageable
    - What we want to change our current priorities based on Governor's task force
    - Identify the charges/top priorities
