### Recommendations from Ad Hoc Gatherings – Jason Glozier, Kevin Coughlin, Shanna Jensen, Sara Muhlbauer

- Presentation shared with council
- Thank you to everyone who joined the Ad Hoc Groups and attended the meetings
- Thank you to those who stepped up to lead the effort and DHS staff who helped
- #1 Charge – Long Path
  - Identify resources and existing information; how do we gather that and to whom do we send that information to as we move forward?
  - This charge is more of a process
  - More clarity may be discussed at our next meeting
  - The council selects to move forward with all of these new recommendations
- #2 Charge – Medicaid Long-Term Care
  - Which of these recommendations do we want to choose?
  - This is a broad topic
  - Think about this as what we can do first; where's the best place to start for this next year?
  - Short-term Goals selected are:
    - Under Program Authority and Contracts: Review and recommend updates to waiver and contract language.
    - Under Program Transparency and Education: Creating a connection with the newly established Medicaid Member Experience Committee to align and maximize efforts.
    - Under Program Sustainability: Advise on any decisions/impacts related to Medicaid funding reductions or changes to eligibility requirements.
  - Mid-term Goals selected are:
    - All recommendations under Program Sustainability
    - All recommendations under Program Transparency and Education
    - Under Long Term Care Functional Screen: Explore and consider options for a new/improved functional eligibility tool that accurately aligns level of care and needed support.
  - Long-term Goals selected are:
    - Continues from the mid-term goals
    - Under Program Authority and Contracts: Transition to one plan for all aspects of an individual's care, regardless of setting or services received. Would need to consider regulatory requirements for various services, but would make it simpler for people to manage everything in one place.
    - Under Transparency and Education: Continue improvement of transitions between children and adult services.
    - All recommendations under Program Sustainability
- #3 Charge – Workforce
  - Some of the short-term goals are already happening; feel the short-term goals are attainable
  - Will select all recommendations under the Short-Term Goals
  - Mid-Term goals
    - Under Policy, Infrastructure and Advocacy: Align wages with regional living wages to improve retention and attract new workers.
      - Is the intent to have a reimbursement system? Do we need to use another word than "align" to put a solution into the next budget request?
      - Should we do a wage analysis? Broken down by region? There is a tool available – mentioned by Lisa Davidson
  - Long-term goals
    - Select all recommendations under the long-term goals
- Group discussion and next steps
  - Great work everyone
  - Are folks comfortable with the new charges?
  - What are the next steps?
  - We will present these priorities to the Secretary and determine next steps. Nicole will reach out to the Secretary.

- The Ad Hoc Groups may need to meet again after we share these with the Secretary
- It will be up to DHS to prioritize
- What is the strategic planning of what we're trying to accomplish here?
- **Council Feedback**
  - Joel G. – Ad hoc groups were tasked to look at what's most important for each charge; do we need to re-evaluate the ad hoc groups? Jason G. – We really wanted the ad hoc groups to brainstorm some priority areas for each charge; there may be a need for further prioritization.
  - Carrie M. – The ad hoc groups are bringing recommendations to the larger LTCAC group. Important that we're getting feedback from the full group, even those who were not included in the ad hoc groups. Can we actually do all of these recommendations?
  - Chris W. – There should be points from the Program Transparency & Education section to pull out to work on earlier if possible.
  - Jessica T. – Access to records; ease to access their own records; importance of education and availability of people to maneuver and access these programs; aging demographic is not set up to meet the needs of the aging demographics
    - Carrie M. – This may be connected to the Long Path charge
  - LaVerne J. – Addressing an aging demographic is related to the Long Path charge as well
    - Carrie M. – Might add this language into the Long Path charge
  - Cindy B. – Do not think it's beneficial to have a functional screening twice a year; waste of money and time; speaking on the AB163?

#### **Provider Enrollment Update – RaeAnn Fahey**

- Presentation shared with council
- The new system will allow home and community-based services (HCBS) providers to complete an enrollment application and become certified with Wisconsin Medicaid through the ForwardHealth Portal.
- After becoming certified with Wisconsin Medicaid, HCBS providers will be able to onboard with IRIS FEAs, be authorized for services with IACs, and contract with MCOs.
- How can you help?
  - Spread the word to HCBS providers
  - Remind providers to complete the application as soon as possible
  - Share enrollment resources available to HCBS providers
- **Council Feedback**
  - Cindy B. – Not understanding information presented
    - RaeAnn – Vendors must go to forwardhealth to be a provider
  - Chris W. – This was extremely easy to do
  - Karina C. – Group homes have to go through this too?
    - RaeAnn – Yes, all providers who get funding from IRIS or family care MCOs.
  - Karina C. – Is this in a project phase? See lots of pharmacies struggling or maybe due to miscommunication; Can you look into pharmacies and the process of switching medications? RaeAnn will take questions back.

#### **LTCAC Charter Updates – Kevin Coughlin, Carrie Molke**

- Presentation shared with council
- Over the last year, this has been a reset period for us.
- Have been looking at our charter and hasn't been updated recently.
- Purpose of a charter establishes the purpose, structure and rights of the Council.
- Decision was made to create a new charter.
- Highlight some of the changes.
- This is a Secretary-appointed group.

- The 16 appointed individuals will be appointed for 4-year terms now. One of the reasons is that the charges we work on take a long time and more continuity is more effective. They could serve two consecutive periods.
- Current charges will be posted on the website and will be shared with the council.
- **Council Feedback**
  - LaVerne J. – Regarding membership, is there language about striving for ethnic diversity? Should this be added? Please try to add this if possible.
    - Kevin C. – There wasn't anything in the previous charter; will take this back for consideration.
  - Jason G. – Within membership; do we want to specify a tribal membership?
    - Carrie M. – Will take it back for consideration.
  - Kevin C. – One change in membership is that we have about 27 members now but this will be reduced to 16 members; done through attrition; this will be a change in the charter.
  - Linda B. – Any reference to attendance? Is there ever a discussion for a face-to-face meeting?
    - Carrie M. – Yes, kept the same attendance process as before. Not sure about the face-to-face meeting. We will take this back for consideration.

### **AARP Age-Friendly States – Amber Miller**

- Presentation shared with council
- AARP was founded by Dr. Ethel Percy Andrus.
- Working with communities to commit to working with AARP for 5 years to be as livable as they can.
- **Council Feedback**
  - Helen S. – Question about the age-friendly health systems; some initiatives started in WI? Don't see AARP as part of that list? This will be exciting with the Long Path charge.
    - Amber – Doesn't ring a bell; Amber will reach out to them.

  - Carrie M. – Went to Advancing States Conference; there's so many opportunities to use existing framework;
    - Amber will send some additional links; feel free to do an internet search on AARP livable communities; each community and state should start moving the needle to be age-friendly

  - Shanna J. – IRIS Waiver timeline? Summary?
  - Joel G. – Brought this topic up last month. Is there an opportunity to meet with other MCOs? Invite MCOs to next meeting for an update? How things are working from their perspective?
  - Cindy B. – Invite the Secretary to attend a future meeting?
  - Chris W. – Need for dental care and anesthesia

- Michelle C. – What do I need to do about a complaint not being addressed; Please email Joyce Vue at [joyce.vue@dhs.wisconsin.gov](mailto:joyce.vue@dhs.wisconsin.gov)
- Deb – Speak to four things; first, the Ad hoc committees discussion; does this fall under public meeting laws? Suggest seeking legal council; secondly, agree with Mr. Goulker talking about MCOs, appreciating everyone working on this; somebody has to be keeping the pulse of what's happening and pushing for these things; need help in the health and wellness category; there are no providers listed as of now. CRW – one of the standing agencies of this council; encourage to ask about themes raised around the state; council should hear about these themes; lastly, the caregiving fact sheet; did communicate with DHS requires a special need of professionalism; no source data points; no dates; etc. DHS needs to update and re-send out?
- Joseph W. – Hearing about issues in transportation; Are providers responsible? Is there any updates on this? What is the funding for transportation? Can this be a future agenda item? And for the ad hoc committees determined by the bigger group, are providers able to join?
