Department's Commitment

The Department of Health Services (DHS) is committed to ensuring that the Wisconsin Well Woman Program (WWWP) remains strong and available for eligible women who need breast and cervical cancer screening.



Reason for Change

- Very large provider network
 - More than 1,000 provider sites for 10,000 women
- Large coordinating agency network
 - 67 coordinating agencies
- Difficult to provide quality assurance monitoring
- Difficult to achieve efficiency

 - Waukesha (previously existing different model)
 - Washington and Ozaukee

- Modifications
 - Waukesha and Jefferson
 - Washington and Ozaukee
- Final 13 MJAs

2.2 – Funding Allocations (cont.)

- During the transition period, have some extra funding available to assist the new multi-jurisdictional agencies for unanticipated costs.
- Guarantee a stable plan for 3–5
 years. This is recommended to
 provide stability to local public
 health organizations that are going
 to act as the new multi jurisdictional agencies.
- As this new breakout of agencies matures, include some local participation in any recalculation of funding formulas.

2.3 – Strategies to assist with role clarification for coordinators and coordinating agencies

- Coordinator qualifications
 - Add "public health nurse" and "health educator" to the list of specifically defined job classifications.
 - Eliminate the requirement that a coordinator must be a nurse, licensed clinical social worker or physician assistant. Replace this with a list of minimum requirements that a coordinator should have.
- Create time estimates for coordinator work.
- Review feasibility of coordinators making appointments.



2.4 – Transition Plan

- Data (privacy and sharing)
- Communication during the transition
- Interpretation and translation
- Timeline
- Coordinate on transition and long-term planning

Other Recommendations

- 2.5 Referral process to BadgerCare Plus and Marketplace
- 2.6 Translation and interpretation services
 - Standardize materials and have them translated
 - Separate set-aside in the budgets




